RE: MONTHLY REPORT – JUNE 2013

Attached you will find the report for the month ending June 2013.

General Fund:

a) For June 2013:

•	Total revenues received	\$ 1,799,221

The General Fund unrestricted fund balance is \$14,629,368

Revenue collected through June 2013 increased in comparison to the same period through June 2012 by approximately 17.4%. Expenditures also increased for the same time frame by approximately 5%. These numbers are cumulative.

b) City sales taxes collected for June 2013 increased over June 2012 by approximately 12.16%. The current fiscal year through June 2013 increased over fiscal year 2011-12 through June 2012 by approximately 6.74%.

Bed taxes collected for June 2013 increased over June 2012 by approximately 68.78%. Bed taxes collected for the current fiscal year through June 2013 increased over fiscal year 2011-12 through June 2012 by approximately .54%.

Please note previous statements regarding several administrative corrections to this tax category and reference the collection chart shown on pages 2 and 3 of the attachment.

Sales and bed taxes combined for June 2013 over June 2012 increased approximately 18.55%. Cumulative sales and bed taxes collected for the current fiscal year through June 2013 increased over fiscal year 2011-12 through June 2012 by approximately 5.82%.

c) State shared revenue collection for the month of June 2013 compared to June 2012 show increases in State sales tax by 7.39%, State income tax by 21.02%, VLT (vehicle license tax) for Coconino County a decrease of 6.3% and Yavapai County a decrease of 3.44%.

Collections for the fiscal year through June 2013 compared to fiscal year 2011-12 through June 2012 show increases in State sales taxes 4.75%, State income taxes 21.03%, VLT for Coconino County 1.25% and Yavapai County 1.64%.

All Other Funds:

Most of these funds require inter-fund transfers or planned use of reserves to balance their budgets. Sporadic changes to these funds occur because of the large payments made for expenditures on Capital projects as the work is completed. These notes may be more useful as projects are started and possibly completed during the fiscal year.

d) The Streets Fund is funded through the State shared revenues of Highway User Revenue Funds (HURF). These dollars are restricted to use of streets/right-of-way maintenance and improvements. The HURF monies received for June 2013 have increased from June 2012 by approximately 1.58%. Cumulative HURF revenue received for the current fiscal year through June 2013 increased over fiscal year 2011-12 through June 2012 by approximately 8.64%.
