

To Whom It May Concern:

The City of Sedona, Arizona is issuing **Addendum # 2** to the plans and specifications as originally issued at the time of solicitation for bids for the **Maintenance Yard Remodel Project.** For any bid to be considered responsible and responsive, receipt of this addendum must be acknowledged.

As specified in the Instructions to Bidders this Addendum upon issuance has become a part of the Contract Documents.

This Addendum contains 5 pages including this page, 3 changed bid sheets, and 0 plan sheets. Any changed bid sheets shall be used in lieu of the originally issued bid sheets in order to submit a responsive bid.

This Addendum changes the following:

- 1) Bid opening is changed from 2:00 P.M. local time January 8, 2014 to 3:00 P.M. local time January 9, 2014.
- 2) Plans, Drawing A3, Sheet 4 of 15, Specifications, in Section 10B, delete the words "floor and ceiling anchored" and replace with the words "overhead-braced".
- 3) Bid Schedule, Base Bid, Page BP-28, revised Item 11 to remove 'LS' from the 'Unit' column and replace with 'EA'.
- 4) Bid Schedule, Alternate 1, Page BP-29, revised to remove Door 04 from Item 18 and add Door 04 to Item 11. Revised the quantity of doors to 3 on Item 11 and 3 on Item 18, Door 04 is an exterior door.
- 5) Bid Schedule, Alternate 2, Page BP-30, revised to add Item No. 22, Item Description "Concrete Footings", Qty '1', Unit 'LS'.
- 6) Plans, Drawing A3, Sheet 4 of 15, Specifications, in Section 8B, add the words "Flush style, Solid Core, Birch Veneer."
- 7) Plans, Drawing A1, Sheet 2 of 15, General Notes, add Note 14 "Provide 1 1/2" diameter wood handrails at +34" above stair nosing on each side of stairway. Handrails shall extend a minimum 12" horizontally beyond the top riser and continue to slope for the depth of one tread beyond the bottom riser. Allow 1 1/2" clear space between wall and handrail. Handrail brackets shall be securely fastened to sidewalls and shall be able to resist a load of 50 plf. (Reference IBC Section 1012)."
- 8) Plans, Drawing E1, Page 12 of 15, on the schematic diagram labeled "New South & East Interior Lighting Control", change the supply breaker designation from "LA-1" to "LB-37".

I have received addendum # 2 for the Maintenance Yard Remodel Project as described above, and acknowledge it as part of the Contract Documents for the project.
