

he City of Sedona operates under the Manager-Council form of government with six Council Members and one elected Mayor. The Council appoints the City Manager, who is responsible for carrying out policy enacted by the Council, overseeing administration



of the City, and maintaining inter-governmental relationships.


Sedona currently has a staff of 120 full-time equivalent employees and the 2015 total budget is approximately \$38 million. City departments in-

clude the City Manager, City Attorney, City Clerk, Community Development including engineering and public works services, Finance, Human Resources, Information Technology, Magistrate Court, Parks and Recreation, Police, and Wastewater (special districts provide fire services and water). The City has an "A" underlying rating from Standard and Poor's Rat-

ing Services on its most recent bond issuance.

The City has no property tax and relies on sales tax and lodging tax revenues to support its operations. The City has come out of the recession with a reduced workforce, smaller budget, and excellent reserves.

The 2015 Budget reflects a commitment to maintaining core services and a continuing mindset, developed out of necessity as the City navigated the recession, of identifying cost-saving efficien-


he Finance Department provides a variety of services to both external and internal customers. Finance Department employees are responsible for utility billing, accounts payable, cash receipting, payroll, improvement districts, general accounting and customer service. It is a small multi-functional team that exemplifies the benefits of cross-training, teamwork and customer service. It also provides investment and debt management, budget coordination, and facilitation of the annual audit.

The Finance Department prepares both Comprehensive and Popular Annual Financial Reports (CAFR and PAFR), and is responsible for overall financial reporting and management services to the City Council, City Manager and citizens.

### THE POSITION

he Director of Finance reports to the Assistant City Manager and leads a team including one Senior Accountant Manager, one Lead Accountant, and five Accounting Technicians.

The Director of Finance serves as a key member of the City's Leadership Team. The position works within the broad operational and policy framework provided by the Assistant City Manager while providing lead-



ership, mentoring, direction and management for the Finance Department, including budgeting, auditing, treasury management, policy adherence and all operational decisions.

Primary responsibilities include making recommendations to the City Manager and City Council; developing and implementing the strategic direction and policy for the department; developing, imple-

menting and revising operational and financial policies and procedures; developing and managing the annual budget process; setting the tone, climate and vision for the department, ensuring compliance with statutory responsibilities and directives; and ensuring the overall fiscal soundness of the community.

The Director of Finance should be able to delegate effectively and encourage collaboration in the development of a high performing team. It will be important for the new Director to focus on accountability and transparency that demonstrates to the public superior financial management.

The ideal candidate should be an effective mentor and leader and have a track record of Sedona provides the perfect location to live, work, and relax.
