To Whom It May Concern:

The City of Sedona, Arizona is issuing **Addendum #1** to the plans and specifications as originally issued at the time of solicitation for bids for the **Cathedral Rock Trailhead Parking Lot Improvements Project**. For any bid to be considered responsible and responsive, receipt of this addendum must be acknowledged.

As specified in the Instructions to Bidders, this Addendum, upon issuance, has become a part of the Contract Documents.

This Addendum contains 3 pages including this page, 0 changed bid sheets, 0 plan sheets, and 0 additional Technical Specification. Any changed bid sheets shall be used in lieu of the originally issued bid sheets in order to submit a responsive bid.

This Addendum clarifies the following:

1. Technical Specifications, 2.2.3, Item 3 – Remove and dispose existing chain link fence, add to the end of this section, **“Remove and dispose chain link fence, 50 LS, will be a unit change to 50 LF”** This should also be reflected on the bid sheet.
2. Technical Specifications, 2.2.10, Item 10 – Subgrade Preparation, revise this section to read, **“Work under this item shall conform to MAG Specification Section 301 and consist of subgrade preparation for the construction of the retaining walls. Contractor is responsible for damage to adjacent improvements. Payment will be made at the contract unit price bid, and such payment shall be compensation in full for the complete preparation of this item.”**
3. Technical Specifications, 2.2.17, Item 17 – Stabilized decomposed granite walkway, add to the end of this section, **“Decomposed granite color shall be Apache Pink.”**
4. Technical Specifications, 2.2.24, Item 24 – Red Rock Boulders, add to the end of this section, **“Red Rock boulders will be supplied by the City. Stockpile is located on site at the waste water treatment facility. The City does not have a method of loading or delivery.”**

This Addendum changes the following:

1. The Advertisement for Bids,
Contract Time has been shortened from 60 days to **53 days**.

This Addendum adds the following:

2. Sign in sheet from mandatory pre-bid meeting on 03-29-2016.


