1. CALL TO ORDER & ROLL CALL

The Chair called the meeting to order at 2:00 p.m. and requested roll call.

Donna Puckett explained that Verification of Notice is no longer a necessary agenda item, because each agenda shows at the bottom that the meeting was properly noticed.

2. SITE VISIT/DRIVING TOUR OF THE SCHNEBLY COMMUNITY FOCUS AREA (CFA) IN PREPARATION FOR:

a. September 29, 2016 work session and October 4, 2016 public hearing regarding the Draft Schnebly CFA Plan Applicant: City of Sedona Case Number: PZ16-00010 (CFA)

Donna Puckett explained that this work session is actually a guided tour and the Commissioners will be traveling in two vehicles; therefore, Commissioners may ask for clarifications if necessary, but there should be no discussion or expression of opinions, etc., since the session will not be recorded. The driving tour followed the following route: 1) North on Schnebly Hill Road (SHR) from S.R. 179, right into the driveway of the Farley Homestead Historic Landmark, 2) SHR to right on Quail Ridge Ln., 3) North/east on SHR to the Forest Service Huckaby Trailhead, 4) Southbound on SHR to right into the driveway of the Creative Life Center, 5) Southbound on SHR to right onto Bear Wallow Ln to the end of the road, returning through the RV Park, and 6) Southbound on SHR and left onto Gassaway Ln.

The only stop on the tour was at the Gassaway House Historic Landmark. Commissioners walked the grounds and through the house, while asking questions about size of the parcel and the history of the architecture and use of the house. Questions were answered by the owner, Ralph Clemmer or staff.
