1. What are your comments, concerns, ideas, and suggestions about this proposal?

We are residents of the Broken Arrow Development which borders the existing Son Silver shop and parking lot. We are against expansion of the parking lot.

As a local Sedona shop, Son Silver already takes up a great deal of space. It's a giant maze of multiple buildings and structures. To browse its many wares requires a significant amount of time and a good deal of walking. It houses some unique products, but also a lot of cheap and repetitive, mass-manufactured items from China and elsewhere. It's already much larger than any residentially zoned area would permit. And as we know, Son Silver was never permitted to build such a large complex of commercial structures in the first place. They've operated without proper city approval for years, and are only now trying to remedy the situation. It seems they've been forced to come before the city because of their need for more parking space. We find this somewhat disingenuous. Their past behavior should not be rewarded by the granting of additional business space.

We accept that Son Silver is there to stay, and that their business will continue in its present location. Their business is already very good, and that's fine. However, they absolutely must not be permitted to expand their

operations in any way. The traffic congestion they bring to the neighborhood cannot be allowed to increase. They cannot keep expanding their operations. They've already hit the expansion limit. If they wish to keep expanding, let them do so at another location in a commercially zoned part of town. That would be a better business model for them anyway, allowing them to serve a wider customer base.
