The following serves to clarify, that improvements for both the Mystic Hills and Chapel Lift Stations will include replacement of the existing wet wells:

- 1. Part I, REQUEST FOR QUALIFICATIONS (RFQ), PURPOSE, replace the second sentence of the second paragraph with: "Capacity improvements at these facilities will primarily focus on increasing pumping capacity, but are also to include replacement of wet well structure(s), and related devices."; and
- 2. Part II D, SCOPE OF SERVICES, paragraph heading titled <u>Chapel Lift Station</u>, second paragraph, add the following to the bulleted list: "Replace existing wet well".
