To Whom It May Concern:

The City of Sedona, Arizona is issuing **Addendum # 2** to the plans and specifications as originally issued at the time of solicitation for bids for the **WWRP Tertiary Filter Improvements Project.** For any bid to be considered responsible and responsive, receipt of this addendum must be acknowledged.

As specified in the Instructions to Bidders this Addendum upon issuance has become a part of the Contract Documents.

This Addendum contains 9 pages including this page, 2 changed bid sheets, 2 plan sheets, and 0 additional Technical Specification. Any changed bid sheets shall be used in lieu of the originally issued bid sheets in order to submit a responsive bid.

This Addendum changes the following:

1. **Technical Specification 11366B, Section 2.02A, Manufacturer** change as follows:

Manufacturer: One of the following or pre-approved equal:

- 1. Aqua-Aerobics System, Inc.
- 2. **Technical Specification 11366B, Section 2.04.G.4.a.1**: Change pump model number as follows:

Gorman Rupp, model 12B20-BI T2A60

3. Technical Specification 15050B, Section 2.01.B.6, Stainless Steel: Add as follows:

Stainless Steel (unless otherwise specified)

- a. As specified in Section 05120 Structural Steel
- 4. Technical Specification 15050B, Section 2.05.B.2, AGMA Class II Service: Add as follows:

AGMA Class II Service (unless otherwise specified)

- a. Use more sever service condition when such is recommended by unit's manufacturer.
- 5. **Technical Specification 09960, Section 1.07.A.2:** Delete as follows:
 - 2. SSPC QP 1 certified
- 6. **Specification 09960, Section 3.10.B.3.b**: Change as follows:
 - b. Completely cover the substrate above filled voids by 1/8 inch (125 mils) of thickness.
- 7. Specification 09960, Appendix B (page 09960-6): Change EPX-C-6-BSC table as follows:

Parge Coat	Completely cover the substrate above filled voids by 1/8
	inch (125 mils) of thickness
Total	60 125 mils dry film in addition to the parge coat.

The minimum total coating system thickness shall be 125 mil DFT. Individual system coats shall be as recommended by the manufacturer.

8. **Drawings: REPLACE** drawings M-01 and M-02 with the attached.

Description of changes: Changed the valves on the discharge of the backwash pumps to be shown as flanged instead of threaded, to match the specification. Added "TYP" in several locations to clarify typical requirements. Other minor clarifications.

9. **Bid Schedule: REPLACE** the "Bid Schedule" on Page 27-28 of the Contract Documents and the "Bid Schedule – Revised by Addendum #1" issued as part of Addendum #1 with the attached Page 27-28 "Bid Schedule – Revised by Addendum #2".


This Addendum clarifies the following:


- 10. Specification 09960, High-Performance Coatings: Question/Answer
 - **Q:** Is dehumidification/heating actually required? This is non-standard for Arizona.
 - **A:** Dehumidification/heating is required when ambient/surface conditions do not meet that required by the manufacturer.
 - **Q:** Is NSF certification required?
 - A: NSF 61 certification is only required where a coating is in contact with potable water and does not apply to the filter.
- 11. Specification 03300, Cast-In-Place Concrete: Question/Answer
 - **Q:** Do the designers/city have a pre-approved concrete mix design?
 - **A:** We do not have an approved mix.
- 12. Specification 15050, Common Work Results for Mechanical Equipment: Question/Answer
 - **Q:** Does requirement for 316 SST apply to filter equipment?
 - **A:** No. Filter equipment shall be 304 SST per 11366B.
- 13. Q: Are there portable power requirements for MOPO's when electrical service is down?
 - **A:** No, portable power will not be required.
- 14. **Q:** What is required for Quality Control/Inspections by the Contractor?
 - **A:** The Contractor is responsible for material testing. Special inspections will be done by the city.
- 15. The estimated value of the project is \$1.5M.
- 16. The pre-bid attendance sheet is attached.


