1. CALL TO ORDER, PLEDGE OF ALLEGIANCE, & ROLL CALL

Chair Levin called the meeting to order at 5:30 p.m., led the Pledge of Allegiance and requested roll call.

2. ANNOUNCEMENTS & SUMMARY OF CURRENT EVENTS BY COMMISSIONERS & STAFF

Chair Levin referenced a recent email from staff and reminded the Commission that they won't need to call the role for each motion, and at the suggestion of the City Attorney if on this development or other items in the future, if you plan to vote no and can signal the Chair, or Vice Chair in her absence, that you would like to have a roll call vote, it would enable her to do that initially, and then we will have that nay vote recorded by name, and thereafter, you will be asked to state a reason for your vote to deny.
