### **Discussion/possible direction** regarding the following:

- a. Update on Historic Preservation Commission (HPC) Work
  - i. Recognition Program First property has been recognized, Sedona Art Center. Plan on the next series of recognitions to be on the walking tour (cited later in the agenda) so that we can tie these together.
  - ii. Annual event This year's event honored the Sedona Art Center as the first recognized property. This is done annually and plan to continue to hold an event every May.
  - iii. Uptown walking tour app/brochure Creation of a new tour, possibly starting with a brochure and then expanding into an online walking tour that can be accessed through the City website as well as through the Chamber of Commerce (working with the Chamber of Commerce on this).
  - iv. New process for Certificate of No Effect The HPC added a process of Certification of No Effect which allows the historic landmarked property owners to more easily do repairs and minor work without the need for a full HPC meeting.
- b. Update on Conference
  - i. Each commissioner will explain the importance to them of this conference and how it helps them perform their service as members of the HPC.
- c. Landmark Program Incentives
  - City provision of small grants This was done in the past and there is interest from the HPC to resurrect it but the program would need an overhaul to work. Discuss why it is felt to be an important tool.
  - ii. Preservation economics How our older buildings, whether landmarks or recognized, lead to tourism and the increased values of those properties.
  - iii. Fee waivers
  - iv. Assessments of new landmarks Review properties that fulfill the requirements for Landmark, this changes every year with properties coming to the 50-year age mark.
- d. Grant Seeking
  - i. Reinstitution of CLG grants This grant, from the federal government, has been reinstated. Commissioners will explain the grant and how it was applied in the past and how it can be applied now.
  - ii. New grant seeking Need to know the boundaries for the HPC to seek grants. Review grants that have been made to other cities to complete Landmark projects.
