SUMMARY STATEMENT

<u>Background</u>: This item was added to ensure opportunity to discuss the latest updates with the COVID-19 pandemic and the City's response.

The situation regarding the COVID-19 pandemic has continued to evolve since the last Council meeting. Significant changes since then include:

- Governor Ducey issued an Executive Order to "stay home, stay healthy, stay connected" through the end of April that mandated closure of all non-essential businesses and service and prohibits non-essential travel.
- Governor Ducey issued clarification on "essential services," which mandated the closure
 of barber shops, beauty salons, massage therapy services, spas, and tattoo parlors. The
 clarification gives further guidance on closing park amenities.
- City offices have been closed to the general public through the end of April consistent with the stay home order.
- The US Forest Service, with cooperation from City staff and support of the Mayor, closed five popular Sedona area trails and trailheads to deter visitation. These closures are in additional to numerous other actively managed Forest Service amenities already closed due to COVID-19.

The City maintains regular communication with state and county health departments, hospitals, other healthcare providers, emergency responders, emergency managers, and policy experts. These calls focus on:

- Testing supplies, protocols, and results
- Hospital and healthcare capacity and planning
- Planning and standing up new testing centers, quarantine sites, and mobile medical care facilities
- Mobilizing additional resources including personal protective equipment (PPE)
- Clarifying rules and regulations regarding state and local orders and proclamations
- Clarifying support resources including federal and state funds and local non-profit programs

In addition to the daily coordination of items listed above, City staff has been working to identify resources to deal the economic disaster resulting from voluntary and forced business closures. Molly Spangler, the City's Economic Development Director, has been tracking federal and state bills and programs. With partnership with the Chamber, she has also been presenting information to impacted businesses. The programs are still in a state of flux as rapid increases in demand for support outpace the lawmaking and administrative processes associated with distributing support.

Lastly, City staff has maintained communication with area service providers to assess needs and provide assistance and to organize community member resources. Megan McRae, the City's Management Analyst, has maintained close contact with providers and is integrated into the Arizona Community Foundation grant process for COVID-19 related funds. Through that collaboration and consistent with Council direction, financial support has been provided to two organizations with a contract history with the City: Verde Valley Caregivers and the Sedona Food Bank. Karen Osburn, the Assistant City Manager also helped stand up a program in partnership with the School District to provide a facility for homeless persons to get showers. Staff continues to monitor programs and rules meant to support community members in need. Similar to the business assistance programs, these programs aimed at individual support are in a state of flux as demand greatly outpaces capacity.

While significant staff resources are dedicated to the COVID-19 response, many departments maintain steady work demand. All essential services continue and even non-essential but important functions like building and development permitting and inspections also continue. Capital projects are proceeding at a relatively normal pace, although some staff shortages have created some delays.

City staff is beginning a more thorough assessment of the potential financial impact to the City. The largest impact will not be from unanticipated expenses but from the steep decline of City revenues. Cherie Wright, the City's Finance Director, has monitored the reports by various economists and other governments. She has also created a model that allows us to estimate economic impact through key variables like hotel occupancy. This model relies heavily on the analysis that attributes sales and bed tax collections between local and visitor spending across industry sectors. Lastly, we are beginning to identify a tiered approach to responding to

economic declines correlating to a relatively short and mild recession to a severe and prolonged one.
