- Submit written comments to the Recording Secretary.

  - a. Discussion/public hearing/possible action regarding a request for approval of a variance from Sedona Land Development Code (LDC) Section 5.5.D(1): Minimum Required Off-Street Parking, Table 5.2: Required Off-Street Parking Sapces, Household Living, Dwelling, Single-Family Detached. This section of the LDC requires single-family detached dwellings with more than 1,500 square feet to provide a 2-car, 400 square foot garage. The applicant is proposing a 735 square foot addition to an existing 1,038 square foot house, which would require construction of a garage under this code section. The applicant is requesting a variance due to lot size and topographic constraints. The subject property is located at 81 Quail Ridge Lane, is approximately 0.40 acres, is zoned RS-18 (Single Family Residential), and is further identified as Assessor's Parcel Number 401-10-006A.
