The other two items we have scheduled for October 6th are a work session item for a review of the Saddlerock Conceptual Development Review, and then we have some requested changes from Ambiente, so that development plan will come back to the Commission for action. Since one item is for a work session, and the other two are for action in public hearings, we have decided, in case the Saddlerock conceptual review goes more quickly and would leave a lag between meetings, to post that as one continuous meeting starting at 3:30 p.m., and as soon as we are done with the work session item, we can move right into the action items.
