











Adult Intensive Care Beds in Use by COVID Patients



Recent deaths may not be reported yet. Cases missing the date of death are excluded from the graph above, but are included in all other numbers.



• Coconino: Cases as of 12/8/: 8,344 - up from 6,977 on 11/24 (+20%)


• Yavapai: Total cases as of 12/8: 7,125 - up from 4,746 on 11/24 (+50%)


• Greater Sedona: Total cases as of 12/8: 481 - up from 322+ on 11/24(+50%)

CDC definitions of transmission:

Minimal Community Spread: Evidence of isolated cases or limited community transmission, case investigations underway; no evidence of exposure in large communal setting.

Moderate Community Spread: Sustained transmission with high likelihood or confirmed exposure within communal settings and potential for rapid increase in cases.


Substantial Community Spread: Large scale, controlled community transmission, including communal settings (e.g., schools, workplaces).





- US Cases = 196k daily avg. last 7 days highest YTD (up from 171K two week ago)

- 48% of cases in greater Sedona came in the last four weeks, meaning cases have almost doubled in less than a month
- Data from Yavapai and Coconino Counties indicates 0-5 deaths

Community Support

- Winter advertising markets in CA are on pause Phoenix remains
 - Some ad campaigns target masks and other safety protocols
- Hotel Occupancy continues to improve
 - Weekly occupancy around 76% for the last 4 weeks
 - Approximately 2% below normal for the last 4 weeks
 - Average Daily Rate (ADR) is more about 16% above previous year for the last 4 weeks
- No new direct financial support to community organizations



City Finances and Operations

- June sales tax better than expected
- July sales tax down about 3%
- Aug sales tax up 13%
- September sales tax 10%
- Continuing limited open hours 8-12 Monday through Thursday
 - Growing concerns could lead to office closures
- Five confirmed cases among team members
- Financial outlook: cautiously optimistic
