1. CALL TO ORDER, PLEDGE OF ALLEGIANCE & ROLL CALL

Chair Levin called the meeting to order at 4:30 p.m. and waived the Pledge of Allegiance.

2. ANNOUNCEMENTS & SUMMARY OF CURRENT EVENTS BY COMMISSIONERS & STAFF

Commissioner Gajewski and Commissioner Zonakis were welcomed to the Commission, and at the Chair's request, they provided a brief summary of their background.

VOTE: Motion carried six (6) for (Braam, Furman, Gajewski, Hosseini, Levin and Zonakis) and (0) opposed. Commissioner Brandt was absent.

a. Discussion/possible action regarding a request for renewal of an existing conditional use permit to allow for the continued operation of a weekend farmer's market in the Wells Fargo parking lot. Applicant: Katrin Themlitz (Sedona Community Farmer's Market). Case Number: PZ20-00005 (CUP)
