Vice Mayor Jablow advised that he attended an Airport Board meeting yesterday. There was a presentation from the USDA regarding funding for a rural water system at the airport which would support more business. Molly Spangler was credited for bringing the USDA and Airport together. The Airport continues to receive helicopter noise complaints with 612 so far this year. There is also concern over low flying powered parachutes that are noisy and dangerous. Councilor Chisholm attended a Sedona Recycles meeting, and advised they are thankful for City support. They are having trouble disposing of plastics due to low oil prices. He also attended a NACOG Head Start subcommittee meeting which he now chairs and is on the Advisory Council on Aging subcommittee. NACOG may host a meeting in Sedona on October 28, 2021 and the host city normally gives a tour of a local project for which he needs ideas. Councilor Lamkin attended Coconino Plateau Water Advisory Council and Coconino Plateau Advisory Partnership meetings last week and was elected the vice chair.
