6. Section G, a request to clarify the procedures of how a board should resolve the question of benefits under this section.

Motion: Board Chair Kinsella moved to authorize the Board Chair and secretary to draft and finalize a letter to the AZ Public Safety Personnel Retirement System regarding the 6 items that have been identified for comment for the HB2381 Draft Model Uniform Rules for Local Board Procedure, by the November 10, 2021, deadline.
