To Whom It May Concern:

The City of Sedona, Arizona is issuing <u>Addendum #2</u> to the plans and specifications as originally issued at the time of solicitation for bids for the <u>Chapel Road Shared Use Path Improvements Project.</u> For any bid to be considered responsible and responsive, receipt of this addendum must be acknowledged.

As specified in the Instructions to Bidders, this Addendum, upon issuance, has become a part of the Contract Documents.

This Addendum contains <u>9</u> pages including this page, <u>3</u> changed bid sheets, <u>0</u> plan sheets, and <u>0</u> additional Technical Specification. Any changed bid sheets shall be used in lieu of the originally issued bid sheets to submit a responsive bid.

This Addendum clarifies the following:

- 1. Relocation of boulders Attached, page 4, shows current Mystic Hills monument locations and relocation area
 across Geneva Drive and existing boulder that needs to be placed per exhibit. Page 5
 shows the other boulders that need to be pushed to the Right-of-way/property line, back
 away from new SUP on Lot 37.
- 2. Bid Item #25 reads "5-INCH CLASS A CONCRETE REPLACE DRIVEWAY MAG SP340 2 LS"

 Driveway replacements are listed as lump sum. There are 2 concrete driveways that will need to be cut, remove existing concrete (bid item #17), place AB to new grade to match SUP trail, form and pour concrete and finish similar to existing drive (i.e. one driveway is grev exposed aggregate (page 6) and another is Sedona Red (page 7)).
- 3. Bid Item #17 REMOVAL OF EXISTING CONCRETE 1 LS Where is this work called out on plans. Please clarify.

 This note refers to removing the concrete drives associated with Bid Item #25 to then replace the drives.
- 4. Bid Item #33 reads "SALVAGE ROCK & RE-GRADE DRIVEWAY 12 LS"

 Typo. Should be 1 LS, refers to existing gravel driveway at approximate Sta 0+45.
- 5. Bid Item #42 THERMOPLASTIC PAVEMENT MARKING (24" SOLID WHITE CROSSWALK BARS Sheet TS-13 states that this item includes both 12" crosswalk and 24" stop bar white thermoplastic striping. The 24" stop bar striping is not shown on the plans. If this is included in this item, please clarify as to the location(s) on the plans. Location @ 28+30 striping of the cross walk. There is no stop bar.
- 6. Bid Item #44 SIGNS, POSTS AND BASES This item includes the remove, salvage, and relocation of existing street signs as well as the installation of several types of "new street signs" as indicated on sheet TS-14 & TS-15. Please clarify and quantify these "new street sign "locations/types on the plans.
 2.2.2.15 Speed Table Ahead Signs, DELETE FROM SCOPE OF WORK. All signs by City of Sedona.

- 7. There are not pavers proposed at Lot 26 driveway alignment at this time. Correct
- 8. Driveway at Lot 27 Grading is anticipated to be within the Right-of-way.
- 9. Driveway pavers at Lot 35 See page 8, Exhibit 5, of this addendum regarding the addition of the pavers for this driveway. Bid Item #26 is updated.
 - 10. Driveway at Lot 37 Temporary Construction Easement in process.
 - 11. Detail for culvert through headwall at Sta 24+00 See page 9, Exhibit 6, of this addendum which is a draft detail of the pipe penetration. The final detail will be signed and sealed by the structural engineer who prepared this detail.
 - 12. Replace Road Edge Striping Not included in scope of this project.
 - 13. Dry Stack Wall on Plan Sheet 4 & 5 do not have start and stop Stations identified Anticipated linear footage is included as Bid Item #35.

- 2. Updated Bid Schedule attached.

BLUE- Reshape swale for drainage




