### **Program Eligibility Requirements, Services & Guidelines**

- Residences must be homeowner occupied. No tenants or renters are eligible for the Home Energy Retrofit
  Project at this time.
- Residences receiving services must exist within Sedona city limits.
- Applications must be complete. Incomplete applications are subject to dismissal.
- Applicants' funding eligibility will be in relation to reported income against the Area's Median Income (AMI).
- Funding provided to CozyHome LLC for eligible applicants will be given at the following tiers:
  - Tier 1 Income Level 80% or less of AMI: \$5,000
  - o Tier 2 Income Level between 80 and 100% of AMI: \$3,500
  - o Tier 3 Income Level between 100 and 120% of AMI: \$2,000
  - All completed applications are eligible for \$100 coverage of an energy audit with CozyHome LLC.
- Funding allotments to be provided are based on applicant self-reported income levels in Part 2. Applicant responses are subject to auditing and additional information requests to verify applicant responses.
- CozyHome LLC, in partnership with the City of Sedona, will provide home weatherization and retrofitting services for approved homeowner occupied residences which may include but not limited to:
  - Duct Sealing
  - Air Sealing
  - Insulation Repair

- Lighting Upgrades
- Mini-split Installations
- Heat Pump Installations

#### **Legal Agreements & Disclaimers**

- All weatherization projects and services covered by this agreement are subject to availability of City of Sedona funds allocated to the Home Energy Retrofit Project.
- Applications received will be reviewed on a first come, first served basis.
- All work performed under the Home Energy Retrofit Project will be performed by CozyHome LLC. No other contractor or vendor is eligible to receive funding from the Home Energy Retrofit Project.
- Information from the energy audit, services rendered, and utility performance changes will be shared by CozyHome LLC with the City of Sedona.
- Homeowner(s) do not receive funding directly. Any monetary amount an applicant is approved for is invoiced and provided to CozyHome LLC for weatherization and retrofitting services under the Home Energy Retrofit Project Agreement.
- Homeowner(s) agree to not rent out residence receiving services for **ONE (1) year** after the date of receiving services. This includes utilizing residence as a short-term rental (STR).
- Homeowner(s) agree to not sell residence receiving services for ONE (1) year after date of receiving services.
- The City reserves the right to audit and request additional information and documentation from applicants to verify claims made on this application to ensure the validity and integrity of the program.
- The City will provide **SIXTY (60) day** notice in the event the application has been selected for auditing and income verification before additional information is requested.
- Applications that are selected for auditing and income verification will be chosen at random, unless allegations of misrepresentation, falsified claims, or incomplete documentation is reported or found.
- Applicants may face civil and criminal penalties and prosecution if an applicant has been found to misreport, misrepresent, or falsify claims made on this application.

## **Privacy Notice**

- Meet federal or state reporting requirements.

#### Do you have to give us the information?

You have the right to not provide the information requested.

### What happens if you give or do not provide information?

If you provide the requested information on the application, your application will be processed. If you do not provide the requestion information:

- Your application will not be processed.
- You might not receive services.
- Your services might be delayed.

The City of Sedona will keep whatever information you provide, whether or not your application is approved in accordance with local, state, and federal laws. No identifying information will be sold or shared to outside parties without your express written consent.

#### Why is information asked about your race, etc.?

This is voluntary information. It is compiled and recorded for statistical purposes only. The program cannot discriminate for reason of race or ethnic background, religion, gender, sexual orientation, or political affiliation.

## **Your Rights and Responsibilities**

#### You have certain rights to get help:

- To appeal within 30 days after you are sent the results of your application if:
- You receive a denial letter and think wrong information was used to make the decision.
- You do not receive the help you were promised.
