- Traffic congestion (x5)

 homeless standing on our street corners begging for money. There are a lot of available
 jobs for them to fulfill. The list goes on...
- We need sources of income that do not rely on tourism
- We need to address the excessive use of ATV's, helicopters and other tourist types of adventures that create issues for residents.
- We need to take that money that we get from the resorts and we have to put it to good use which does not mean advertising for the resorts bus hubs do not belong in the middle of town they belong in the outskirts when people in the neighborhood say I don't want this in my neighborhood you should listen this is not gonna be a self-sustaining town we're very rare occurrence we are what we are we're not going to be picking cotton we're not going to be making tricycles we don't need industry in this town we're just fine as a Taurus town as long as we can contain the driving which We can do
- We urgently need sidewalks on Dante and Rodeo and Coffee Pot from the Sanbourne thunder mountain corridor to 89A, they are dangerous to walk or school children to get the school bus. Our council built a hugely expensive sidewalk on Sanbourne and Thunder Mountain that goes nowhere. What we need is some common sense in building sidewalks for the safety of the citizens. It's like the bridge that went nowhere, it's the sidewalk that goes nowhere.
- Where to put new roads and parking lots.
- Whether Sedona will have the creativity and determination to design and establish sustainable and environmentally responsible transportation systems to restore our spectacular Sedona
- Why are tours being taken through residential neighborhoods, like West Sedona.
- Wilderness protection. Less ATV access to trails/forest roads etc.
- Wildfire prevention
- Work to allow residents to have proper and travelable access to trailheads. Join with the
 Forest service to address illegal parking at trailheads and the large amount of overflow
 into residential neighborhoods.
- Workforce housing

- Your shuttle system is a joke. Human behavior is as follows: tourist will fill the parking lots, then fill the neighborhood, then as a last resort go back and find a shuttle.
 Neighborhood parking has to be totally off limits
- Zoning changes that allow for more density other than Developments that are 100% TRUE workforce housing which is needed

Is there anything specific that you'd like to see addressed in the Community Plan update?

- I'm in west Sedona. Now surrounded by Airbnb's, Killing the community vibe. The owners not present. Yard maintenance minimal. Dark sky rules not being followed. The visitors have no respect for the land ,the wildlife. Very disappointed city pushing tourism.
- Increase in number of police and fire personnel to be able to handle population growth. City procedures for the operation of Short Term Rentals, to include an enforcement mechanism for noncompliance with established guidelines.
 Meaningful and realistic planning to mitigate future traffic increases. Again, placing priority on full and part time residents.
- Short term rentals from non-residents or RETs are jacking up prices and
 restricting those folks who work in Sedona to afford to live here. It is destroying
 the "community" aspect of the town and all things we hold dear. There needs to
 be rules against foreign investors, RETs or other tax shelters from buying our
 property and shutting would be locals out
- restriction from building anything at the Dell beyond the needs of the wastewater plant redevelopment in west Sedona to address housing in the form of high density mixed use
 in the area of Bashas and surrounds making that into the downtown we do not have. 4-5
 stories. Trade increase zoning for redevelopment address more creative land uses and
 less hotels. look at the concept of density transfers to encourage redevelopment. eliminate trailhead parking and link all the trailheads by greatly increasing trails so
 everyone can walk from their hotels or homes to where they want to hike without their
 car.
- Stop polluting our neighborhoods with so called improvements, it is not for the benefit of the people that live here, but to divert traffic away from 89A into the neighborhoods. It is appalling! -do away with R B and B's or limit with whatever means possible limit traffic on Dry Creek Road, it is becoming a circus!
- Traffic
- 1, 2 and 3.
- Tlaquepaque needs to pay to have something done so that pedestrians don't stop cars. The city should force it. I cannot believe they were allowed to do what they did (building across the highway) without thinking of the rest of us and how

we have to get around this town. I'm SO OVER IT! 2. Think of your residents who chose to bring their families here and live. It's not all about the tourism money. Please reign in the chamber of commerce. 3. Please encourage the hiring of lifeguards so that the pool can stay open year-round. You have no idea how many people want to swim on a regular basis in a lap pool. Allocate the funds so that the pool can stay open. Provide lifeguards for the swim teams because it is such an extravagant cost for teams and they are barely making it.

- Better control and Limitations on Airbnb's 2. Building a crosswalk at Tlaquepaque in form of pedestrian bridge or tunnel underneath the road which will be a great help in reducing the traffic which backs up on HWY 179
- I can see that the City is trying to incorporate traffic solutions but they aren't enough. (The Uptown improvements have been helpful, though. Thank you!) There are simply too many cars (see suggestion 4 below). I like the idea of emptying out the parking lot at Tlaquepaque by the back way, Brewer Road and Ranger Road. Excellent idea. I don't know if that is completed yet or not, but I hope it will be. SR179 needs to carry more traffic which means the Tlaguepaque area and SR89/SR179 junction need to be improved and carry more traffic. Those are the snarling points. 2. I am glad to see that parking has been prohibited in Oak Creek Canyon. Now there needs to be a transit system in the summer months, where people park and take a shuttle or bus, like at Zion National Park. I propose the idea of limiting the number of visitors to Slide Rock and West Fork by creating a reservation system. 3. Affordable housing has been a hot topic for YEARS, and yet nothing has been done. An attractive, wellconstructed apartment building (or two or three) would make a big difference. But the prices need to be actually affordable. It doesn't help if the rent for an apartment is \$1,500. A studio shouldn't cost more than \$600, for example. 4. We need to stop advertising, which brings in more and more people as tourists. We can still have a healthy tourism industry without additional advertising. The world knows about Sedona and visits it. We don't need to spread the word even more by marketing it. It is so hard for us who reside here to use the beautiful natural places because of so much tourism. If we want to take a hike, it's nearly impossible because the trailhead parking places are full to bursting. Sometimes it feels that Sedona exists for the tourists, not the residents.
- A Community Plan instead of the apparent tourist attraction such as a Disney world plan. Our streets need attention, sidewalks, crosswalks, crowd control and enforcement. Trash is a real problem in our neighborhoods. Renters of short term AIRBNB properties couldn't care less about the trash they leave. Good luck with that one.
- A far more definitive picture of what a growing, habitable and balanced city would entail, with specific goals on demographic balance (particularly age and income) and alternative engines of economic growth. Is it our goal to be a shrinking city hamstrung by short-term rentals, limited healthcare and traffic congestion?

Clearly not, but today's plan focuses far to much on the "how" and ignores the "what" in what we think Sedona should be. We really need to go back to basics - how many residents, how much schooling, how much and what type economic activity...do we need to think of merging with VOC to create a viable long-term city? These are hard questions, but if we get them right, we can build support and funding to achieve.

- A local road to circumvent and bypass 89a
- A more assertive action plan on environmental sustainability.
- A more detailed exit strategy in the event of wildfires and a need to evacuate the town in 24 hours or less. Currently, there are only two ways out of the city, routes 89A and 179. In the event of an emergency, there would be few options for residents.
- A new mayor and Control and manage short term rentals
- a pedestrian bridge at 179/Tlaquepaque not sure why this was never part of the approval of the expanded version of Tlaquepaque - a pedestrian and traffic nightmare. fresh water supply and water sustainability concerns need to be addressed
- A way to bring families back to Sedona so we can maintain our community. And another way to get from the VOC to Sedona. That way more parents might stop taking children to Cornville due to not wanting to travel 179 daily.
- Accelerate getting the walking way access for crossing into TLQ finished. You've talked about it for three years. It could have been built long ago and alleviated that traffic bottleneck. Speed up all decisions and action. We need to be known for beauty and culture, not for being SLOWDONA.
- Actually asking uptown residents about their unique concerns and potential solutions instead of strictly relying upon consultants
- Address the horrific traffic on 179 which used to be a weekend problem, but is now a daily challenge.
- Affordable housing, traffic, education Stop advertising that Sedona is a paradise destination!
- Airbnb has taken all of the housing for lower and even middle class folks. These
 folks are the fabric of the culture of Sedona. Much of the tourism is built on the
 "eccentric middle class" here- aliens, energy healing, vortexes, shamanism, etc.
 etc., not just on beautiful scenery. People come here to experience this, not just
 take selfies in front of the rocks. This culture will be eradicated if these folks
 continue to be shoved out.
- Airbnb is slowly taking over this town. Tearing through HOAs and destroying the traffic, making it impossible for new families to settle in. We need a stronger

sense of community. As a 31 year resident of this town, I have watched it change before my eyes. The attraction of wealth that this town draws is nothing short of incredible, we need to put that money back into the people that live here, that want to raise children here and have multigenerational families. Sedona is one of the most affluent small towns in this country, why do we not have more public parks and open spaces? If we want to attract families, we need more beautiful parks and a family friendly pool. We want our local first responders to be able to afford to live here, to raise their children here.

- Airbnb must be limited. Hotel business is down. Tourists are everywhere in neighborhoods, disrespecting speed limits, leaving dog poo, increasing noise, and decreasing closeness with neighbors. I'm so sorry that Sedona has no limits on Airbnb, and that neighborhoods without a governing board have to allow it. There was no foresight at all regarding the effect on Sedona.
- Airbnb/ rentals have destroyed community... lack of diversity, hard on the land, nowhere for working people to live.
- All of the above!
- All of the above and Climate Change, Diversity, Open Meetings and Posse Grounds being the hub of activity. Pool needs season long April-Nov. Senior swim classes, open swim and lifeguards with ability to work those months with ample pay.
- All of the above, including reliable access to broadband for all residents and businesses. Change state law to separate the regulation of long-term rentals from short-term rentals, treat the short-term rentals like the businesses they are if they are whole-house rentals on residentially-zoned property, allow owner occupied short-term rentals or casitas on owner occupied properties only going forward.
- All of the above. I don't think low income housing benefits life in Sedona.
 Maybe expand the trailer park on W. 89A?
- All of the above.
- all of the above...
- All three of my answers have to do with the total lack of respect that Sedona government has for residents. Every plan made is geared toward tourism, coddling businesses, and gathering a big tax base. I can no longer hike easily because of tourist crowds. It takes an hour to get from W Sedona to the VOC much of the year because you have not implemented a way to stop the bottleneck at Tlaquepaque. You have made no effort to put in bypasses to avoid Tlaquepaque and the Y. Living here full time has become a trial.
- Allow more apartments to be built.

- alternate roads besides 179 and 89A
- Any plan that doesn't include 2 lanes each direction on 179 and/or an alternative route between the VOC and West Sedona is not an adequate plan for the future.
- As I've described above. We can do this while the lands are still undeveloped that can create parking for shuttle busses and parking for an Oak Creek River Walkway.
- As indicated above, we feel the city officials have largely abandoned the needs of our residents. It is no longer enjoyable to live in Sedona. Traffic is so bad that it is difficult to take care of essential needs, let alone go hiking or go to Uptown/West Sedona to enjoy restaurants or the arts. We fear for what would happen in case of a fire. We feel the residents are largely ignored when we bring our concerns to committees or P&ZC. The past and current community plans do not address the needs of residents and the city officials do not seem to care. Please development a plan designed for people who actually live in the city.
- As stated above, the needs of the residents must be represented. City council seems to believe they know what is best for the Community. Their appointment is to represent the interests of those that voted them into office, not their personal perspectives. This has been an ongoing issue and needs to change.
- Ask Coconino NF to enlarge trailhead parking, or create more trailheads.
 Creating a shuttle service does not help residents, who would then have to drive to shuttle parking, wait, and then take a shuttle back to the trailheads. OK for tourists, but VERY inconvenient and discriminates against residents. Ask AZ DOT to create paved 10-minute pull outs on the scenic byway section of SR 179 so that tourists can safely pause and enjoy the scenic beauty.
- At some point, if we don't protect full-time residents, who own homes, contribute to the community via government, faith communities, volunteerism, retail and the like, we may face a time when we loose 50% of our full-time residents. We need more upscale retail. We also need a town square/park where people can gather. Right now the way the city is designed, we are poised for urban sprawl--89A. All retail and businesses, the traffic to get in and out of these establishments are located along 89A. Too many vehicles/congestion.
- At some point, Sedona is going to have to address the many problems of limited infrastructure before it becomes untenable
- ATV restrictions
- Availability of shuttles to local sights to reduce traffic, and parking at trail heads.
- Better ADA accessibility.
- Better health care facilities
- Better management of community swimming pool to increase availability.

- Better police community outreach, police training, and communication with residents. More walking beats.
- Better traffic conditions.
- Better, more intelligent traffic control.
- Both items listed above
- Build a bridge across 179 at Tlaquepaque, North and South. Build the towers with elevators and stairs first so you don't have to close 179. Helicopter the span pieces in.
- Building moratorium!!!!!!!!!!!!!!!
- Bulk waste pickup service monthly or quarterly
- burying electric lines to preserve the views in the community.
- Businesses are suffering because there aren't enough willing workers. Some blame this on the lack of affordable housing. Apparently commuting is unheard of in the Sedona area. I commuted 64 miles each way to a job as a teacher, for 7 years. You do what you have to do, rather than complaining and expecting someone else to solve your problem for you. I feel there is affordable housing down towards Cottonwood, Rimrock, etc. Maybe more apartments would be beneficial in the long run but I don't feel low income housing is the answer.
- Busses or other means to lessen some of the traffic problems
- By far the biggest problem is traffic.
- Cease additional Airbnb's and prohibit nonresidents from having Airbnb's and cease all new hotel builds. Also designate soldiers pass trailhead parking to locals pass only and make tourists use shuttle. This alleviates excess traffic on soldiers pass and surrounding roads. Add parking to teacup lot. Trailhead parking is a complete joke in this town. Get rid of the chamber of commerce.
- Central car free gathering location with restaurants and shops
- Change the law about allowing short term rentals in residential neighborhoods.
 Otherwise all of Sedona is effectively zoned commercial.
- City owned and developed employee housing projects and transit in and around Sedona. Limitations on vacation rentals with city funded enforcement of neighborhood CCRs and negative impacts, such as noise, trash, parking, etc.
- City said there are not enough full time residents to vote on the city plan. If so, Sedona as a city should disband and stop all the high salaries and extremely high benefit packages. Andy Dickey said now 36homes drain onto my property which caused flooding last June. The city allowed the sewer construction people to slant Canyon Wren St. to drain towards my property; some residents actually

cemented their runoff to drain on my property. The city refused to put a drain in the street to avoid this though they put one on Tabletop Rd. immediately when the horse people's horse poop drained into the street. Now that goes directly to Oak Creek. Andy Dickey said a number of years ago that the drain on Canyon Wren would be on the Master Plan. Another lie and the city takes no responsibility.

- Clear growth understanding. The world visits Sedona. The vacation rentals are an important growth enabler for Sedona, if planned carefully.
- Community
- Community Facilities. IE: public pool availability, community classes, yoga, arts. The classes should be offered during the day and evening for those who work.
- Consider building housing in The Dells since Sedona residents are generally not supportive of increased density to create workforce housing. Have a plan to respond to state imposed bills that have adverse effects on local control such as that of SB1350. Also, more connectivity so residents can walk/bike from one end of town to the other without using SR89A
- Construct a Tlaquepaque over or underpass.
- Control and restriction on short term lodging aka Airbnb and making sure people
 are both able to work in city limits and have affordable housing within city limits.
 Shifting from expanding police funding to funding our schools. Honest and open
 communication with our city government and it's residents so that we know
 what's going on in town, rather than using clearly positive language for vague
 projects (I want details!) All the best!
- Control of short term rentals that are destroying neighborhoods. The impact of so many tourists on our neighborhoods and Sedona in general is shocking. I believe the multitudes of people jammed into Sedona is destroying it, causing massive traffic jams and making it unsafe. Many of my neighbors have sold their homes which are then purchased by nonresidents turning them into short term rentals. Please help preserve our neighborhoods before it is too late!
- Controlled limits of short term rentals within and across the community. No more tourism advertising. The outward facing marketing efforts have resulted in Sedona being marketed as the ATV capital of the USA that has lead to safety, resident and environmental issues. Open up alternative roadways / access ways to mitigate the traffic jams on 179 and all traffic having to flow through the "Y" from the South. Traffic management in general, but especially North on 179.
- Crack down on Airbnb's.
- Create a community plan that puts local, full-time residents above tourists and out of town investors/property owners that care more about profits than our neighborhoods/communities.

- Create a system, much like some of the national parks have done...like Zion and Grand Canyon, where tourists park outside the city and are transported in by electric shuttles. Simultaneously, stop the incessant and excessive promotion of tourism.
- Creating a community that is bicycle and pedestrian friendly that allows for access to shopping, restaurants, retail stores without navigating dangerous traffic conditions.
- Crossing at Tlaquepaque, underground with stopped storm drain run off. This is disgusting 1930 design.
- Cut back on the money we spend to the Chamber of Commerce. However the city tries to defend it is very bad optics and is quite divisive. It's outdated. Cut it down to a half \$1 million. Spend the money instead on paying people to patrol trail heads and trails and roads and crosswalks.
- cut down on encouraging helicopter tours and Chamber of Commerce should not spend money encouraging tourism!
- daily living needs for residents of Sedona as important as tourist dollars
- De-emphasize the drive for more and more tourists. It is now self-sustaining (unfortunately) and throwing additional money into promoting tourism is akin to throwing coal into a volcano. Enough is enough and too much our current situation is a real problem.
- De-fund the Chamber of Commerce
- Dedicated Sedona resident / workers discounts at restaurants/ services. Free
 parking at trailheads: let the Chamber manage this with the funds they get. We
 can't stop tourism: but we can work to protect residents from them.
- Defund the chamber of commerce
- Defund the Chamber of Commerce, reduce city employees for the number of residents (less than 10,000) served, stop spending money on ideologically driven programs, focus on GOOD efficient government. Hire someone who knows something about road design and fire those who do not, and get rid of the ridiculous CAP program and the \$100s of thousands that are wasted on that nonsense. Also, if you are going to h ire as new city manager put out an RFP and review qualified applicants including the one you arbitrarily promoted who was trained by a manager who could not manage.
- Develop a food truck park like is found in Moab Utah. It will support small business and relieve the pressure on restaurants
- Do not allow any further construction of commercial buildings until we have sufficient roads to deal with additional traffic. Emergency vehicles can't even get through the roundabouts. Vote against the complex at the top of Airport road, we

- don't need any more hotels, motels, or entertainment venues in Sedona. We already have the Sedona Performing arts Center, Posse Ground Pavillion, The Hub, and many other venues. Enough is Enough.
- Do NOT make zoning changes easier. Commercial entities should create a business that conforms to existing zoning in all areas of the city.
- Due to lack of affordable workforce housing, there is a crisis for local business and they're not being able to find help. Also, the crisis that we have with our healthcare system needs to be addressed as it will force more and more people to move from the area to somewhere where they can get the services they need.
- Each new tourist lodging development adds more cars to an already overburden road structure. Nothing that I've seen to date, is making a significant dent in the problem. Either build bigger roads, limit traffic on the roads, or discourage people from coming. Also, I am an avid bicyclist I have come close (on 89A) a number of times, to being hit by: someone driving in the bike lane, by someone barging through a round-a-bout, by someone using their cell phone or by someone making improper turns. I would whole hardily support cops/volunteers whose sole purpose would be traffic safety and enforcement.
- Each of the above
- Effects of high density housing
- Eliminating short-term rentals
- Employ more police, police support and police patrols within the department in Sedona. I recently visited the police department to report racing and speeding up and down Andante Drive at all hours..muscle cars and their "flooring it "up and down the street as well as the Taylor Waste garbage trucks, landscape trucks.... cars and trucks not stopping for the school buses which pick up children on Andante. No one was at the front desk when I arrived in the morning and 1 person in the building (reported to me, I did not assume). The woman had to put me on hold 3 times before I could speak to the issue I came to report, she still could not talk and said an officer would call me to take my statement. The officer did call me, but he too had to hang up, put me on hold, only to call back later to take my report. Honestly, I don't know what is to become of this beautiful natural wonder we call home here in Sedona if realization of real consequences for overconsumption is not actualized.
- Enforcement of regulations for short-term rentals! If "owners" want to be in the hotel business, they should abide by a similar set of regulations as those real hotel/motel owners must follow.
- Enforcing current building codes, and city policies is not happening to protect the Sedona Citizens: specifically expanding current homes into Air B&Bs of larger sizes with much more demand on the existing septic, lighting, parking systems.

The Air B&Bs are not the issue, it is the lack of control and monitoring of the transition of homes built to accommodate a certain number of occupants and allowing the expansion of these homes without following building codes. Along this same vain, individual homes being converted into Air B&Bs are ignoring the International Dark Sky issue. Many are putting up several lights that totally ignored this policy. Many of the Air B&Bs are owned by investors who live out-of-state, hiring companies to do remodels without concern for neighbors.

- Enhancement of 89A, in Sedona/West Sedona, similar, but not to the extent of uptown enhancements, and those along 179. Partial medians? Roundabouts/landscaping?
- Environmental issues are THE biggest issue in Sedona. As a tourist economy, we need to protect what makes Sedona unique and attractive. Get away from the Disney vibe of ATVs, jeep tours everywhere, "fun" things to do. Focus on the NATURAL attractions and honor the beauty and ecological balance of the natural environment here.
- Everything listed above
- Far more control over short-term rentals throughout Sedona, stricter guidelines and controls over STRs, and a reduction in the percentage of STRs permitted in each subdivision.
- Find a way to make Sedona the quiet, spiritual community many of us were summoned to by her. Tourism pays for much that we appreciate but it's time to think of we homeowners. 3 million tourists per year is plenty. We do not need to build more hotels or sell more houses to be converted into STRs. We like to know who our neighbors are and have that tight knit, small town community feel.
- Flooding problems coming off Thunder mountain and affecting antiquated drainage and lack of curb and gutters. Specifically Andante Drive at Mule Deer Road, North Star and Harmony.
- Focus on the above by shifting the bias to residents, community, and the
 environment over tourism revenue. This long-term approach which is aligned with
 the vast majority of residents will make Sedona equally, if not more, desirable as
 a place to live and visit without destroying what makes it so special. Thank you
 for listening.
- Forest Land protection plans/trail shuttle progress
- From what I've seen of the categories to be worked on, it looked like the Environmental Chapter that was in the last plan was dropped. If so, put it back in!
- Funding dedicated to protect trails and forest roads from ATV damage
- Get cars off the roads. Get that pedestrian underpass done at Tlaquepaque. Improve bike lanes with more signage and rumble strips. Have law enforcement

- start giving tickets for cars driving in the bike lanes. Keep working on affordable housing so we can get kids and families back. Limit short term rentals to only residents who live in the same house so they are immediately available to solve the problems that their renters create for the rest of us.
- Get city out of tourism industry No more tourism websites fund with bed tax 109% of bed tax to benefit residents No more stupid projects that only benefit tourists like projects to uptown
- Get local control of the vacation rental properties. Add a hike/bike trail to link south Sedona with West Sedona via airport mesa. Require permits for ATVs/Vehicles using forest lands near hiking trails. Noise restrictions on all vehicles - especially those going into the hiking areas - Broken Arrow, Schnebly Hill Road (153), and roads 152, 152D, 152C, 152E for example. Ordinances that require convenience stores, fast food, etc. to use natural, unbleached (non-white) material for their cups, napkins, etc.
- GET RID and BAN out of town homeowners for using property for AIR BNB.
 Save real estate for local owners only.
- get rid of short term rentals!!! work with the forest service to limit ATV usage on back roads
- God Bless You all for your service and Love of Our community! Sincerely, Mark Cone
- Good luck on this one! Finding ways to keep both the tourists and the residents happy. Those who live here need to understand the importance of our visitors, and also need to have quality of life as a resident.
- Greater emphasis on projects that benefit the local population (e.g. sidewalks, pickleball courts, road repairs, etc.)
- Guidance, and assistance, to transition homes from fossil fuels to cleaner energy options.
- Homeless community
- Homelessness is by far the worst since many rentals are being turned into short term rentals.
- Housing for workers Controlling ATVs in the forest and camper and RV parking that has spread all over. It should be condensed to certain areas for them to park. Also ATV should not be able to just go where they want or as fast as they want.
- HOUSING must be available and affordable to those working/living in Sedona.
 The community cannot survive if no-one can work & live here

- How about changing the community's priority to making a livable place for residents rather than pumping tourism (and taxes from that) way past the breaking point which we passed a few years ago
- How about cutting back on tourism marketing. This community can't handle the number of people here now.
- How can the community and police provide better control over outsiders who
 occupy short term rentals and are disrespectful of neighbors in the area...being
 loud, not taking care of their garbage, etc.
- How can we grow a more diverse community of different cultures and backgrounds, ages, and socio-economic backgrounds?
- How to equitably handle an out-of-control tourism, traffic and noise issues.
- How to galvanize the community to support quality of life issues understanding we are a tourism based economy
- How to reduce short term rentals. (And this will also reduce traffic potentially.)
 How to make housing (rental and owner) more affordable. How to protect the
 water supply from the various sources, and use water more efficiently water
 supply will become a greater issue all throughout the southwest and Sedona is
 included.
- I am not for the 5G towers, 5G is not good for you. Stop the bed and breakfast places, they make a lot of noise and our population has gone down because of it. People are selling their homes and they don't care who takes it over.
- I believe respect and stewardship of our environment need to be much more than standardized wording it's a commitment that needs to be reflected in every project and development and which needs to be communicated to each and every council person, resident, and visitor. Affordable housing is also an important issue, but if it's going to be funded by tax dollars, affordable housing needs to be restricted to those in need who are working in and/or contributing to this community. What happened at Nepenthe should not be allowed to happen again.
- I do not want zoning to change so that buildings can NOT taller than the existing restrictions. I do want there to be a limit on the number of and restrictions on short term rentals. Restrictions need to require AZ residency for ownership—no corporate takeover of neighborhoods.
- I don't hear anyone discussing how run-down the playgrounds are. They also need expansion of some sort in terms of parking and equipment. Are there other ideas for families? Everyone talks about wanting to keep us here, but no one is doing anything.

- I feel that the Air B and B's that are owned by nonresidents need to be eliminated. This is where the importance of community comes in here. Air B and B's that do not have an owner living on that property should be eliminated.
- I have lived here for 22 years and am upset how this City has developed. Before you have a sustainable and practical traffic solution there should not be any more official advertising of Sedona. Social Media etc. has put it on the map already for free. Provide more sidewalks on residential roads so that one can walk safely to shops etc. The sidewalks do not have to be 8 ft wide i.e. Sandborne (cyclist use whatever they want anyway). 89A in West Sedona is now what we see in many American towns. Ugly shopfronts nothing appealing like landscaping etc. no decorations i.e. on Christmas (other than what shop owners do). Sedona is not just uptown where residents hardly have a reason to go.
- I have way too much to say about the community plan for sure, maybe we all should have a meeting in relation to all that is being proposed
- I know traffic is something that is always being looked at but it is something that really effects quality of life for residents. It has to remain a priority.
- I like to understand what percentage of the sales and lodging taxes we send to the State are returned to Sedona for improvements to continue to generate these tax proceeds, and how those proceeds are spent in the local community to create a continuous, virtuous circle.
- I see no reason for 3 trash haulers on every street in the city. This is not sustainability. Follow examples of what is working in other smaller cities.
- I think it's messed up beyond repair.
- I think that you did an excellent job and the community plan update that I read last month addressed our major issues.
- I understand teacher salaries are very low in Sedona. I would encourage the community to increase this with the hope to attract and keep highly qualified educators.
- I want to see workable, real-time solutions that rebuild our community character, provide housing access, limit the impact of tourism, reduce traffic issues, and maintain the beauty of our environment. As a lifelong resident of Sedona who is married to a lifelong resident and now raising two children (all of our parents still live here as well), I want to see Sedona retain the feel of community that has kept our family here for nearly 40 years. We want to see the families who move here stay because Sedona is so great instead of moving away after a few years because of limited economic and housing opportunities.
- I worry about neighborhood identity crisis which we are currently experiencing due to STR's. STR's will only increase if we do not fully address the issue and

- find ways to temper its growth. Also, the OHV increase is problematic to our daily way of life. Band-Aid proposals will never address the issue head on.
- I would like to mention that with the idea of protecting Sedona nature that the City consider not allowing for activities like Disc Tossing on the trails where our natural beauty is disturbed. Posse Grounds is a good example of this with the recent rowdy players in that area throwing frisbee disks, not following the trail, trampling over plants, accidentally hitting a bird in which fell out of a tree in front of one of my friends one day. Example. It might be fun to play with a basketball in a living room filled with glass vases and important items but doesn't mean that you would allow it. No matter how careful a person would be throwing a basketball in that environment, the chances are eventually that ball is going to hit a glass vase. I know this is not in the City Plan...although maintaining our natural beauty of Sedona and protecting our environment is. This is why I am adding this here.
- I would like to see a city minimum wage of \$27 per hour. A priority placed on affordable housing over new hotel development. City trailhead parking expanded.
- I would like to see some solutions to the horrific traffic backups that happen daily thru Tlaquepaque. I live near the Chapel area and feel like a prisoner in my own home because I know that it will take at least 45 minutes to get thru the Y in either direction. Get rid of some of the air B&Bs, quit promoting tourism. We are a world- widely known area and have enough tourists clogging our trails and roads. Find and BUILD alternative routes. I am ready to sell and move out of this beautiful place due to traffic. Thanks for letting me share
- I would like to see the city establish a public review of RFP projects. Post the plans and Specs on line. The City could invite retired Architects, Retired Construction Managers, and anyone else with experience in this field to comment on these proposed future projects.
- I would like to see the plan address capitalizing on opportunities to create an innovation economy and embrace remote workers as a means of economic diversification and increasing cultural and generational diversity.
- I would love to see more economic diversity. I would like to know more about how festivals are permitted and scheduled. Locals have stopped participating in these events because traffic is so bad; we are "imprisoned" in our homes and neighborhoods. I would like to see Slide Rock, West Fork and campgrounds require permits and reservations. Visitors need to be taught to respect private property. As much as possible, separate trailhead parking away from neighborhoods. Continue to work on Park and Ride options at the Ranger Station in the Village and the Western Gateway area.
- I'd like residents to be treated like residents: for example to be able to park free at trailheads I can no longer do that. And I don't expect to have to use tourist

- transit to get around this is nonsense. So I'd like residents to be issued free parking permits for all public parking including trailheads; and tourists to have to use the new transit system. You cannot push out residents in favor of tourists.
- I'd like to see a moratorium on building until our traffic problems are solved or at least lessened. I'm chagrined to see that "cookie cutter" housing is being OK'd when it is shunned everywhere else. I'd like to see a city that emphasizes citizen's rights over tourism.
- I'd like to see community resources available to the community. We are a wealthy community, we lease a community pool and have a full time aquatic director, yet the pool is only open to the public 3 months out of the year. There are many people that would use the pool year round in our temperate climate and it requires maintenance all 12 months anyway. Through COVID we have lost many of our community traditions, like trick or treating, I hope the council will consider ways to promote community and be COVID safe even if it means developing new traditions. The community plan statements are amazing, I do NOT see them reflected in the decisions or implementation of the last ten years. I do appreciate more bike trails and awareness, but closing a road to a public school on a Friday when it's bike festival day is not making the local community a priority. It's time to remember people live here. If no one continues to reside in Sedona, tourism will not be supported either.
- I'd like to see more public spaces for community meetings and events. SPAC is too prohibitive as a venue for local events. I'd like to see that changed. I'd like to see more spaces and activities for children and families. AND more quality housing options for people who aren't wealthy.
- I've listed my priorities above
- I've lived here over 10 years and worked for the school system in the area for that time. When I walk up and down Rt. 89A I consistently see commercial properties (i.e. offices) that are vacant. Why can't the city partner with these landlords and to find funding to convert these commercial suites to affordable apartments/housing for people to live in. They are attractive, near businesses, the Verde Valley Transit stops and would be a win/win for landlords and renters.
- I'd revisit your questions as they are too broad for today's Sedona. They were directionally correct thinking when made 10 years ago and simply need to be more specific and updated
- I've heard that the state allows air bed and breakfast units, so the city can't
 prohibit these types of businesses. However, we used to own a short term rental
 in Prescott, but the city made running short term rentals prohibitive through
 higher taxes, fees, and periodic inspections and stringent rules from the fire
 department. Prescott has since eased some of these rules, but they don't face
 the quagmire Sedona is in with excessive units and overwhelming opposition

from permanent residences. Sedona could make it less appealing for people to choose to keep their units as short term rentals. As parents with young children, we're concerned about the deleterious effects of a serious lack of young families in this town. Traffic is horrendous. We literally avoid driving from home in the Chapel area to west Sedona anytime after 930 am. Heaven forbid we have an emergency or decide to enroll our kids at the Montessori school on the other side of town. We hear plans for another trailhead on Chapel Road. Quite literally the very last thing we need. I envision trying to get to my house, but stuck in bumper to bumper traffic. Will the city be staffing the roundabout, like Back O beyond, to turn back the hordes of tourists when the lot is full? I certainly hope so, but am skeptical that adequate planning is going into the proposal. Why on earth implement a shuttle for Little Horse Trailhead, located off a highway, but then allow additional parking in a neighborhood? A more logical solution would be to allow parking at the highway trailheads, but implement a shuttle through the neighborhoods.

- I've seen the community plan look fantastic sound good intentions great and I do
 not see the action behind that following through we are not supporting the small
 schools we are not supporting our own small businesses we are voting and
 pushing for big business this is not what we should be doing I see the direction
 going in another way looks pretty on paper action is not happening
- If possible, changing zoning away from hotels and resorts that give the tourist industry more power in inviting tourism, which affects the amount of tourist that come, increases the challenges in protecting the environment of the city and natural beauty and solitude of the area. It seems to me that the more hotels and resorts gives the industry the power to define and shape our community instead of the community of people of Sedona.
- If they are planning to close trail heads, then LOCALS SHOULD NOT HAVE TO GET ON SHUTTLES WITH TOURISTS. Easy solution, locals obtain passes to put on their wind shields. If that is still too many cars for the trail heads, then allow locals who have lived here 10 years or more.
- Improvement of the crossing at 179 and Tlaquepaque. Why are people allowed to cross given priority to traffic?
- Improving the dirt roads torn up by off road vehicles
- In an effort to address traffic, the City gave up the few areas that were intended
 for residents. The loss of "The heart of Sedona" aka, the Brewer Road Ranger
 station. And putting the trail transit hub at Posse Grounds. We have lost Posse
 Grounds. Without adequate healthcare, residents will have to travel outside the
 area or move. Affordable housing has begun to be recognized and addressed.
 But more is needed.

- Incentives for more robust, quality health care services. There are massive wait times to get even basic health care locally.
- Integrated and effective transit that does not negatively impact neighborhoods; restrict corporations in all areas of progress; more than 50% governmental focus on affordable housing and diversified local economy; family and children support.
- Interlocal cooperation to address issues that extend beyond Sedona to include Village of Oak Creek and Cottonwood. Specifically alternative routes from south of Sedona to West Sedona
- Investigate and move ahead with ways to change the law allowing short term rentals in Sedona
- Is there a way to get Schnebly Hill paved to Mogollon Rim. Would make another way to get to and from Sedona.
- It really does seem like the residents have been ignored and that tourism is the #1 priority. Everything from constantly increasing traffic, even to interference in neighborhoods to accommodate tourism, not to mention Airbnb's, seems to shout "tourists first!". We have been here 32 years and the changes haven't just been dramatic -- they have been traumatic for full-time residents. Every time we elect a new mayor and council, we talk about the same things and the same promises are made, yet things tend to get worse, not better. We need to put our residents first! Someone needs to be listening to them.
- It would be nice to be able to ride/walk from West Sedona to Uptown, and from Uptown to the Village of Oak Creek, without having to share 89A and 179 with autos. I realize this is probably not feasible, but it would be nice, nonetheless. Like Flagstaff's urban trail system. Large, paved bike roads that could accommodate e-bikes would probably help ease traffic and be a safe and enjoyable way for people to get around. Bell Rock Pathway could be paved, then signed paths through the neighborhoods and wide sidewalks might accomplish this task from Uptown to VOC.
- It's been three years since the residents of Uptown were promised the Forrest Road Extension and nothing has been done yet. We, who live in uptown, have put up with traffic problems, parking problems, and people who casually tie up traffic walking against the lights in the crosswalks. Another issue is the city's Code Enforcement Department. We have had several homes that are being turned into STRs in our neighborhood. These homes are being remodeled without permits. Code Enforcement has been notified and yet, nothing is being done to stop it. WHY?
- It's great to have such lofty goals but implementation is key. Construction
 projects that take months like the mainline sewer at Hillside area are not good.
 Projects that take place during high tourist season, like the roundabouts last
 year, are not good. Simple planning failures there. How can you hope to

- implement such lofty goals of self-defined 'sustainability' when local businesses are driven out of town because the various levels of red tape? Only the rich can survive. If the sustainability is to win, it has to start somewhere in the organization and relationship levels.
- It's a known fact that city staff have blocked affordable housing initiatives for decades. Now residents must leave their community in droves—it's shameful! Now that you've lost the staff to work in your million dollar resorts, I guess your choices are finally coming home to haunt you? The crosswalk at Tlaquepaque needs to be closed. Parking on the north campus should be equivalent to the needs of the businesses on the north campus. Tlaquepaque should pay a penalty to residents.
- Keep and expand use of the Cultural Park for use as a concert venue.
- keeping the pool open 10 12 months opposed to the 2 3 currently. Try to attract young families to move here.

- Less tourism, please. Peaceful town where locals can enjoy hiking trails without crowds of tourists. Peaceful weekends without events and crowds.
- Less tourists and fewer hotels.
- Let's get something done. And not another study!
- let's really clean up our city. Have 2 days a month that volunteers report to a specific area to collect debris and clean specified areas.
- Limit Airbnb. I am now surrounded by Airbnb's and they do not respect Sedona's Dark Sky designation. They have too many outside lights illuminating driveways and porches.
- Limit STR to having owner on site too.
- Limit total STRs in Sedona with a lottery and permit system. Allow ADU unit to be rent short term if owner occupied primary. Create a permit/fee system to limit hiking, biking, off road and creek use. Allow a limited number of visitors with a

free pass for residents. Create an alternative route from VOC to Sedona! Create additional connections thru neighborhoods to allow local traffic to travel off 89A.

- Limiting short-term rentals and ATVs.
- Living in RV's and trailers on city streets, rights of way and on lots zoned for other purposes is not good for the city, and should be stopped.
- Living in Sedona does not feel like being in a community, it feels like being in a
 tourist town. How and when will obvious issues be addressed and not just given
 lip-service? More visitors will not help, more traffic will not help, more
 roundabouts will not help, more hotels and Airbnb's will not help yet, these have
 been increasing every year. It seems like there's no turning back from how far
 away Sedona is from being a community.
- Lobbying the legislature to regulate short term rentals Limit the zoning for new hotels Aggressively seek senior living developments so that as people age they're able to stay in Sedona
- Local schools.
- Locals given priority access to parking at trail heads.
- Locals having preferred trail access
- Make new construction account for future water usage. I don't ever see
 affordable housing here, so top all the new hotels and restaurants if they can't
 account for places that their workers can afford to live in. Fix the sewer rates.
 You spent a ton on money on that study and then nothing was done!
- Manage the transient people panhandling on every corner.
- Money Sedona has spent to help control traffic has just enabled more traffic. The Y to uptown and to 179 is still a horrible bottle neck. Put traffic lights there instead? Widen the round abouts? Teach idiots how to use a round about? Tlaquepaque and the roundabout there at Garlands is STILL a horrible cause of bottle neck traffic. Tlaquepaque should be forced to consider measures to help with traffic such as creating two more entrances to take pressure off traffic. We are fed up with what Sedona has become and consider leaving. We do not need one more hotel!
- More bike and walking paths Not more roads or bridges
- More dedicated pickleball courts at Posse Grounds Park.
- More effective use of our resources such as the Performing Arts Center and Barbara's Park.
- More Electric Vehicle charging stations

- More encouragement of other types of sustainable clean industries, businesses, or permanent residents is needed. Short-term incentives could be offered. The over-reliance on tourism growth needs to be tempered.
- More focus on the local community rather than the tourist community in decision making, if the local community is cared for they will be able to care for the tourists better.
- More reliable public transportation instead of more parking.
- More respect and consideration given to full-time residence. More concern for open spaces. A decrease in building everywhere. Following the existing zoning codes would be especially appreciated.
- More sidewalks like Sanborn and multi-use trails like what has been proposed for Chapel (i.e., what has been put up Soldiers Pass) vs. buses/trams. With the advancement of e bikes, these sidewalks/multi use trails and ample parking for ebikes could be the wave of the future for Sedona residents to get around town...
- More thoughtful structure regarding housing- vacation rentals, reasonable housing options for the many service workers supporting the Sedona economy
- Much more focus on residents and much less on tourism. Where are local parks along Hwy 179, where are Creek walks?
- Natural resource preservation. If we ruin this environment with overuse by OHVs, the environment may not recover. We need to provide low impact opportunities to tourist to appreciate the natural beauty of our beloved Sedona and it's red rocks. Sedona should lead the southwestern states in recycling and caring for the environment (do we need mandatory recycling?)
- Need more respect for the land and local people
- New development, i.e. housing, should only be permitted if adequately supported by infrastructure. Roads, Water, Gas, Electricity. See 1st.
- No 5G towers Stop building up Sunset Drive traffic is horrific. Less ATV's Less Airbnb's and a place for the homeless and backpackers to shower etc. More Dancing – clubs. More places to dine for organic food. More support for the Arts
- No dense housing at all. We need wild spaces and we need to protect them from further degradation. This is crucial.
- NO ebikes on the trails. There are too many hikers and bikers already. Ebikes go
 faster and twice as far as pedal bikes; therefore, they do twice as much damage
 to the trails. Don't allow them here!
- NO MORE approving hotel, motel, larger than 6 unit Short-term housing buildouts until affordable long term housing is available for all that currently live here.

- No more high risers. Respect the Environment. Reinforce trails rules.
- No more hotels. We need workforce housing ASAP
- No need to advertise Sedona ever so no money should be appropriated for advertising for tourism.
- No parking garages
- No personally because of medical problems in our family. We must move after 23 years. We are going into assisted living with no view. We have sadness because of how our council and chamber grew our town from 1 yellow blinker light at the y to the mess we have now.
- Noise pollution and harm from OTVs. Favored road and restaurant status given to residents. Senior playscapes and a community recreation center
- Non flow of traffic near Tlaquepaque Synchronize traffic lights in W Sedona along 89A
- None other than the issues stated above.
- Nope see above and thanks for listening.
- Number 1 are the traffic issues about Uptown and West Sedona
- Of course traffic is scary and building more Roads to get into and out of Sedona is probably the answer. More daily tourists will not solve the problem ...
- Open Verde Valley school road to provide alternate route into and out of Sedona
- Overbuilding. Sedona has lost it's way in that the citizens are not treated with respect by the city. Stop giving taxpayers money to special interest groups.
- Overcrowding, maintaining open space
- Overturn or amend SB1350 to stop businesses from operating short term rentals.
 Make homeowners of rentals responsible and available within 30 minutes for complaints. Enact stiff fines for violations.
- Parking
- Parking requirements should be evaluated Does shared parking really work?
 The weekly tent art shows are a downgrade for Community Why so Many?
 Who collects the tax?
- parking spaces dedicated to residents at trailheads
- Pay attention to resident concerns as much as you do to commercial interests
- Pay council members a realistic wage. Get folks with deep city planning experience and pay them well. Stop taxpayer funding of the Chamber of Commerce.

- People in my neighborhood are renting out their homes with short term rental
 companies even though our covenants prohibit doing so. There appears to be
 little support from the city for controlling these properties. I live off dry creek and
 am shocked at the number of tour operators and ATVs driving up and down the
 road. It doesn't feel so quaint and beautiful now.
- Please define SUSTAINABLE. In the 2013 Plan it uses this word but never tells what it means and thus achieved it not. Be more specific than using this nondefined generalization.
- Please don't engage in greenwashing. If it's truly not sustainable don't pretend it
 is
- Please figure out a way to connect Upper Red Rock Loop and VOC. This would alleviate some of the traffic issues on 179 and the traffic circles at 179 and 89a. There has to be a solution!!!!
- Please, please continue to regulate -and eliminate (haha), the investments by large corporations that buy up and greedily exploit our business and destroy our residential communities for creating Air B&Bs. Please address the influx of tourists by continuing to limit or manage their access to our roads and the natural treasures that they are trampling, disrespecting and destroying it and in so doing well severely affecting the quality of ;life for us the residents.. both human and animal.. This place is no longer the place I loved and moved to so many years ago before it was "discovered". I want to leave, as many have done and would, if I were up to it. .And of course, you are aware of the diminishing population and the negative resultant effects that leave me with a feeling of powerlessness. here is really no longer community oriented place and no longer the Sedona I loved. Please fight for us the residents- in your decisions affecting and reversing the direction of Sedona's future.
- Please stop developing in the most congested part of our traffic nightmare!
 Thank you for keeping our Police Department a top priority! Thank you for keeping our Fire Department a top priority. Thank you for our wastewater program.
- Protect the environment., decrease the off road vehicles. Decrease traffic! It is horrible for locals. Stop allowing short term rentals where they were not intended (Sedona west development). Don't allow out of town owners to rent homes nonstop. It destroys the community feel of a neighborhood.
- Protecting the environment and wildlife. Protecting quality of life and privileges for full-time residents (resident parking permits, periodic bulk hauling of yard or other debris particularly after storms, holidays etc., supplementing community pool and services, portion of bed taxes to provide creative benefits to full-time residents). Increasing preservation of open spaces and tranquility. Limiting development. Insistence or lobbying to YC for a seat at the table to better manage and

hopefully limit airport expansion, impact and use on the city, especially by military aircraft. Cleanliness and trash pick-up. Stop encroaching into neighborhoods and environment with new roads and bike paths that disturb privacy, tranquility, safety - it does not improve traffic it only increases capacity. Healthcare.

- Protection of quiet neighborhoods from too much traffic and noise due to growing number of short term rentals
- Protection of the environment and community from over tourism.
- Provide a working definition of "sustainability" in all of its dimensions when envisioning and developing community focus areas. Explain what "teeth" the CP has in project funding and zoning decisions. Provide tangible examples.
- Put a moratorium on new buildings (water supply as we head into a decades long drought).
- Put a stoplight at Tlaquepaque that stops vehicular traffic for pedestrian crossings every 15 minutes. The pedestrians can shop until it's time to cross.
- Put the word "community" back into every decision making process. Is this good for the community and not just for the tax dollars city will make. What affect will this decision have on residents. Allowing a citizens council to be formed where residents can bring concerns to that citizens council who in turn will bring it with recommendations to council. Citizens get 3 minutes to voice their concerns and when those hearings begin, council is bored as they already have determined how they will vote-regardless of citizen input. It's ever too late to strive to return to community. The beauty of Sedona has been thwarted by the \$\$ sign. Protect as promised on past community plan, old Sedona! Hopefully you will re-read it especially those parts relating to the heart of Sedona!!
- Quality of life for the residents of Sedona should be a priority over bringing tourist dollars to the City Council and Chamber of Commerce. Do not turn Sedona into a circus of tourists coming through town without a respect for peace and the spiritual quality of Nature.
- Real solutions for congestion in uptown, Tlaquepaque and on the 179. Address housing crises due to number of Airbnb's.
- Reclaim Uptown for its residents and change it from the very down market tourist trap it has become.
- Recognition and acceptance of the fact that this is a tourist town, and the city should start acting like one. Instead of residents whining that the city does nothing for them, people need to demand that the city take a leadership, active role in managing tourism. Controlling tourists is the biggest thing that would benefit residents. The Chamber is sales and marketing, not in a position to manage tourists that use city streets, parks, etc.

- Reduce the number of short term rentals
- Reduce the percentage of short-term rental in town
- Reduce tourism! We have had the services we need at the tourism levels of 2005. Now those services are being cramped by over-tourism. The grocery, traffic, utility, and property services are being overused because of tourism. The tourists using the new DISK GOLF course are destroying the forest around Caruth trail by running off trail and climbing trees to get their disc's damaging tree limbs.
- Reducing short term rentals to increase long term rentals. Addressing the noise from the airport and stopping low flying over residential areas.
- Reducing short-term rentals and excessive tourism to fix our housing and traffic issues while attracting a better healthcare provider than NAH. We need more focus on resident issues--housing, healthcare, traffic. Less focus on making a small group of business owners even more money.
- Regain control of short-term rentals
- Relief for full-time Sedona residents subject to the horrible conditions that result from proliferation of short-term rentals causing overcrowding, intolerable traffic conditions and pollution. The crosswalk Tlaquepaque to Tlaquepaque North creates obvious and dangerous safety condition for pedestrians, and incredibly congested traffic conditions. Make better decisions than this! Open Schnebly Hill Road to the freeway, and Red Rock Crossing for car travel from VOC to Highway 89A. These 2 measures alone will greatly relieve traffic problems.
- Removal of climate change and sustainability initiatives.
- Restrict ATV use
- Resurfacing of streets in some residential areas. They are in bad shape.
- Return of investment analysis on any actionable item undertaken by the City Council
- Revisit the Red Rock Crossing as an alternate route between hwy 179 and 89A.
- Ridiculous traffic congestion!!!!!!!
- RIGOROUS CONTROL OF OFF-ROAD VEHICLES
- Road connections and improved storm water management between subdivisions in West Sedona, particularly South of 89A. North of 89A in West Sedona, major capital improvements to alternate connectors, walkways and drainage have been completed. Connections between El Camino and Blue Jay along with several other subdivision connectors have long been discussed. Possible alternate routes from Airport Rd to 179 have been proposed for 30 years (Citizens for an

- Alternate Route/Ivan Finley) but never successfully made it into planning phases. As private land is developed in these areas, the window of opportunity closes!
- Sedona is beautiful, and everybody deserves the chance to come and visit. But this town is famous for its quaintness and its people. We are losing Sedona to massive amounts of traffic. I live in uptown, and people are parking and camping in RVs outside of Airbnb's, the traffic is bumper to bumper, so if I have to go anywhere during the day it takes at least an hour to get home from West Sedona. I have lived in the Verde Valley for 21 years. My name is Lara Wilson, I've taken the citizens Academy class at Sedona police station, I've worked for the city of Sedona as a temporary employee between jobs, and I know a number of the police officers and firemen in the area. I feel that I have a better perspective on what it's like to live in the Sedona area over people who just buy property here to turn them into Airbnb's.
- Sedona bureaucrats and the wealthy people here have been talking about AFFORDABLE HOUSING for all income groups for more than 25 years now! Seriously, I remember the issue was front and center 25 YEARS AGO! And it's just been horse hockey!!!!! They have been wasting money, lots and lots of money on one survey after another and after another about affordable housing for over 25 years now!!!!!!!!! They just don't want to share with lower income people! Enough with the Bull*%#!.
- Sedona could and SHOULD be a jewel for how to support the natural environment in a way that drives the economy with innovative, GREEN practices, and focus on spiritual renewal. This means QUIET (no ATVs, minimize air traffic, fewer cars, etc.), respectful uses of the desert (NO MOTORIZED ATVs or JEEPs going everywhere, destroying the desert floor, and stressing out the wildlife). It is utterly inconceivable how these ATVs are allowed to take over the forest and destroy the environment. Come on! This is not rocket science.
- Sedona is a community of 8,500 residents and 2 million tourists. Tourism
 appears to be a much more important issue to the City than the needs and
 desires of the residents. As a result, the quality of life for the residents is
 continuing to diminish. Because the city funds the Chamber of Commerce there
 should be resident oversight and input regarding budgeting, spending and policy
 practices of the Chamber.
- Sedona is about the rocks ... how to view them, enjoy them, walk, bike and run
 on them, preserve their adjoining forests and streams and do whatever we
 possibly can to protect them for future visitors and residents. I'd like to see a
 more focused advertising and public education effort -- supported by the City, the
 Chamber of Commerce and residents -- to distill Sedona's amazing natural gifts
 into a simple, clear, unambiguous identity that captures all of the above. Certainly
 not a simple task, and one that probably requires professional input. And, yes,
 financial commitment as well.

- Sedona is known (also) as a Safe community with favorable statistics. Keeping Police and Fire services funded and current, are Public Safety benefits that also reduce City liability.
- Sedona must find a solution to the tourist destination ethos. Without a successful plan, Sedona will simply become "Disneyland" with no community core. For a look at Sedona's future, view Cape Cod or Nantucket Island.
- Sedona needs to stop advertising in Phoenix. The Phoenix clientele is not the
 right one for Sedona. We need to attract less tourists, and a different type of
 tourists, like in Vail, Carmel by the Sea or Aspen. Tourists with thick pockets, in
 less number. Sedona needs to become a luxury destination to keep its precious
 beauty. Low income housing should be outside of Sedona, like Cottonwood or
 Cornville, NOT in Sedona. Millions\$ houses do not mix with low income housing.
 When you spend between one and three million for a house, you do not want to
 have low income multi-family, multi-ethnic neighborhood, with all what it entails.
- Sedona should be the trendsetter for how to live and work in harmony with the land, animals and residents. Our mayor and her council have been too focused on serving the booming tourism rather than the residents- whom are the actual community and working minutia of the city!- and we are suffering greatly. The quality of life has continued to deteriorate for all whom call this home. I'd like to see our needs being prioritized and regulations being placed on Airbnb's. If you actually live in this city and choose to Airbnb a space, sure, fabulous! But corporations coming in and buying out 40+ properties just to Airbnb and turn a profit, has grossly disturbed the equilibrium of this town. This must be addressed or Sedona will lose all that we revere about it. Thank you for this opportunity to voice my concerns.
- Sedona should use models of successfully managed tourists towns and not be so heavily influenced by town businesses that are only concerned with maximizing their profits at the expense of the quality of life for those who live in Sedona.

Even with new efforts like Sedona's down payment assistance program, there are no homes available to purchase, and those that are available are economically out of reach for the majority of local workers. Even when the homes become available, they are often scooped up by third-party investors (with ample cash) who see a chance to exploit our beloved home. Perhaps a cooperative could be formed to support local aspiring homeowners who actively contribute to the vibrance of the local economy, much like what the also beautiful town of Telluride, Colorado has done.
- Services and Building Community for the Residents versus all of the attention given to Tourists and millions given to the Chamber of Commerce.
- Short term rentals and affordable housing
- short term rentals control/legislation enforcement of light ordinance
- Short term rentals, traffic

- Competition for ideal Affordable Housing per 1 acre lot. Change of zoning ordinances to allow in residential zones.
- Support young families who want to live here, drive an economy that encourages jobs and affordable housing, enhance healthcare for younger families
- Sustainability
- Take a look into the community and residence of Sedona and take your eyes of the tourism and money for a second. The city is being ruined by tourism and money schemes. The nature of the land has become a commodity instead of a reward. Why not take advantage of preserving these lands so that it can sustain itself for hundreds of more years to come. Get your noses out of the air and take care of the people who are the backbone of this city. The rich won't work, and the poor will move to a better place where they can thrive!
- Teach real sustainability, not just sustainable tourism, but a return to using the Dells for a growing environment to educate the country on what with a work, grow, live movement.
- The above 3 items I listed are not in any particular order as I believe all 3 are equally important now and over the long-term
- The balance between tourism and needs of full time residents. I have lived here for 20 years and have come to feel the city is gearing itself more toward the CA resident who is here for 2-3 days than it is to me. I came here as a tourist myself, but I did not, nor did most tourists, leave trash on the trails, terrorize residential neighborhoods that happen to be close to ATV or hiking trails, or disrespect the quiet after 10 PM.
- The biggest part of the traffic problem is the constant bottleneck at Tlaquepaque due to traffic having to stop for pedestrians in the crosswalk and no other bridge across the creek for vehicle traffic through town.
- The city codes are enforced east of Andante but ignored west of Andante
- The city needs to have and enforce rules about littering, noise, and on-street parking. The city must find ways to hold residents and businesses alike accountable for renters who violate the aforementioned ordinances. The city must also find ways to hold festival organizers accountable for the behavior of festival attendees. The city should invest in PSA marketing and education to protect the trails on which residents and businesses alike depend against destruction, erosion, pollution and litter. The city should charge for services related to tourism to help pay for the education and enforcement programs mentioned above.
- The city needs to work with the National Forest Service to preserve the environment. ATV's need to be regulated- our subdivision looks like Mad Max

during busy seasons. Traffic is horrific! Something needs to be done to alleviate the bottlenecks on 89A and 179. The reduction in the number of full time residents has had a direct impact on neighborhoods, schools and the overall quality of life of residents. Does Sedona want to be a community where no one lives and takes an interest in what happens here? I feel like that is the fundamental question that needs to be answered. Current practices, albeit a result of state regulations, are destroying this community.

- The community plan should be focused on improving the safety and quality of life for full time residents and not for tourists.
- The infrastructure must provide for the amount of population (tourists and residents).
- The most important issues facing Sedona over the next 10 years as I wrote about in #1, #2, and #3 needs to be addressed and acted on in the Community Plan update. #1 Significant traffic and congestion in the City or Sedona. #2 Less focused on Tourism... too commercialized. Protect the Environmental experience and beauty of Sedona. #3 Transit and walkways where people are walking on main streets to a tourism attraction like the Chapel. (Putting the City of Sedona at greater risk of Liability!
- The need for emergency preparedness.
- The need to restrict Airbnb's from investors that buying up homes to turn them into Airbnb's. Shuttle to trail heads seem to be working. Maybe an expansion of that.
- The proposed shuttle system to alleviate congestion.
- The quality of life in Sedona is poor due to tourism. Please make it stop. There are too many motels. They were supposed to encourage longer overnight stays; they haven't. They have just created more traffic. There are too many Airbnb's. Too much tourism is destroying the trails and backroads. Have I mentioned too much tourism!?
- The Ranger Park on Brewer Road needs to be completed asap.
- The Shuttle to Dry Creek area could not solve the vehicle issues there. With company during Easter did a drive there. Was solid with vehicles parked on both sides of Dry Creek after residential to not only on right to Seven Canyons, also to past the turn to Enchantment Resort. We're the 2nd to Grand Canyon in the State of Arizona. Promoted by our Chamber of Commerce to visit. Very happy on the Forrest Rd project. Open to meet with anyone interested to talk further.. Please, please bring in the additional roads & services to both residents and visitors.
- The Sunset/Shelby loop services several high-density neighborhoods. I'm concerned that the proposed commercial development atop Shelby will bring

more traffic and noise that will adversely affect quality of life for the neighborhoods. Also, please do not allow bus lines in the Sunset/Shelby loop. Need additional evacuation routes out of Sedona in the event of natural disasters. We do not need more hotels.

- The Tlaquepaque and uptown bottlenecks.
- The things I wrote above.
- There are fights all over the country (in popular locations) regarding vacation rentals and affordable housing for the vital people that work the jobs that support tourism. I encourage the city to look to other cities for ideas on ways to control/remedy the situation. A permit system with an annual limited quantity, a fee system for all complaints, and a portion of the rental fee going to transient room tax dollars to be used for city beautification, trail maintenance, traffic cops, etc. There needs to be a sustainable way to support our locals, cater to the tourists and keep Sedona from being loved to death.
- There are too many visitors who have little awareness and concern about protecting the natural wonder that is Sedona. There are many places around the globe that make their visitor focus on ECO-TOURISM. I would like Sedona to take that approach with our future - we can provide education and shift our focus from wild and rowdy to a peaceful appreciation of the quiet, dark sky, arts, culture, and natural world.
- There has to be a limit to the number of cars coming into our fair city. It is simple
 physics. It will only get worse and worse if they are not LIMITED in some way.
 The sooner this is recognized and acted upon the better.
- There is a need to move away from the use of black asphalt for our roads and parking lots that will add to heat in our neighborhoods for pedestrians. Let's apply a form of cool pavement to prevent this added heat affect. Let's use our treated sewage water for greening Sedona if at all possible either by piping it back to town or transporting it with EV watering vehicles. Water can be used to green the 89a corridor (as much as ADOT will allow) and side streets for pedestrians.
- There is overuse of the term "sustainability." The questions you have posed to us
 in this survey connect this term with so many other positive things. Being in favor
 of those other things does not mean residents want to become known for
 "sustainability." We need to be practical.
- There should be less emphasis on economic growth. Is "diversity of economy" just a euphemism for unadulterated economic expansion? Can be interpreted differently. There should be more emphasis on preserving the natural environment and serving the residents who actually live here.
- There's an increase in air quotes with the homeless by choice and they aren't really homeless, where they lost their jobs and are homeless they are addicts.

They come to Sedona to live outdoors. There's no place for them to work here. Law makers encourage you to donate to the shelters but you don't know if they are doing families or doing people who are coming in overnight. We don't know what they are doing. These people are coming here and panhandling and calling their friends to come to a newly built shelter. They need to stop encouraging people to come and use the shelters. It is going to turn into another Prescott.

The last time I counted there were 13 + OHV Rental companies that have taken over the beauty of what was once quite peaceful airspace. Then around 7PM they bring them back. This is all ridiculous and very upsetting. Some have people riding in people carriers staring into our houses and the constant roaring of OHV even on Sunday morning they break the sound of peace. I believe along with many citizens that the City of Sedona Government wants to get rich by constantly using the CVB and the Chamber of commerce to continue to ruin this once beautiful community by flooding it with thousands of tourists while abusing us with loud OHV and making us feel like we are birds in a cage with the people carriers that drive the numbers of tourists by. Then they have the Sedona Run where they black off roads and keeping people from their daily duties. Then the turn a no parking road in a beautiful community into a parking lot for tourists.

- We are in an absolute crisis in terms of housing in our community. Those of us that rent are terrified of what will happen when our leases come up each year the rent increases are out of control, and there are no viable options for the working class of the city. If we can't find a way to curb this problem and offer more housing solutions for the local workforce, all the local economy will suffer for it.
- We are killing the "golden goose" with noisy planes and OHV's. When peaceful hiking-biking are no longer possible, Sedona loses its attractiveness.
- We are simply not providing enough funding for maintaining our neighborhood roads. The current and less expensive chip seal process is terrible. We spend a little over \$1,000,000 per year to pave all the neighborhood roads in Sedona. We should be allocating at least \$3,000,000 per year and repaving all interior roads every fifteen to eighteen years. We now have \$1,000,000+ homes with washboard streets in front of them. There are a lot of progressive things that will be wonderful to do for those that live here and for those that visit our wonderful city but we should make sure we do right by those that have made Sedona their home.
- We live in West Sedona and we never go to Uptown or down to 179 because of heavy traffic congestion. It is easier to travel to Cottonwood than in my own town which we have lived in for 25 years. It is not a community any longer more of a tourist attraction now. Beginning to think the town wants its residents to leave for Airbnb's to take over the whole town.
- We must develop alternative routes of travel
- We MUST have a new connection from the Village to West Sedona. Our roads are barely sufficient for residents, but when tourists come the city is not prepared. There have been TWO studies about the traffic costing \$250,000 each in the last 20 years...nonsense. The study came back with info about what time of day to

- travel...are you kidding people who work can't drive when traffic "might" be light. Get to work and make Sedona good for residents too...not just the tourists.
- We MUST have another route connecting 179 & 89A. Locals are stuck in traffic (as well as tourists) for way too long. would think that the length of time spent stuck in traffic would reduce the time and therefore money that is spent in Sedona. Also, the amount of time spent in traffic increases vehicle exhaust/pollution in Sedona. I would think that would be an important issue as well for police and fire departments. We understand that there was a bridge that connected 179 & 89A in the past so why can't we put funds to rebuild/improve that route. Sedona has a lot of tourists already; why not re-purpose some of the Chamber of Commerce budget to building that bridge?
- We need a new mayor and city council members who will take immediate action;
 not in the 10 years ahead, but now! Now next year, now!
- We need better solutions to our traffic problems!
- We need more bike lanes and a safer way for bikers to get through the roundabouts
- We need some kind of employee housing. We need apartments/entry level living (RV parks?) that are not for Airbnb rentals. We have owned and operated a restaurant in the VV for the last 21 years. It has never been so difficult to find employees. The wages are not the issue (my dishwashers start at 18/hour, my managers earn around 65k/yr for a 40 hr work week). They cannot find housing, let alone "affordable housing". I have 3 Airbnb's just on my block, about 60 in my neighborhood (Chapel area). The rentals that housed our staff in the past are now Airbnb's. We will never get rid of that, so we need to work on adding entry level housing like apartments and even RV parks. The old curmudgeons that do not care about employee housing," NIMBYs", are also that ones that complain about service, hours and prices. We need to find a balance. We need to address entry level housing options.
- We need to immediately get a handle on the traffic issues as well as limit the number of visitors. This can be achieved by as the local ordinances to ensure that all of the visitors stay in highly regulated accommodations. We must build a portal parking lot south of Sedona and visitors must take public transportation
- We need to significantly limit above. More needs to be done for people living here. Roads & drainage ditches are in need of repair
- What can be done about the proliferation of STRs? Aside from the annoyance factor (bad behavior), there is now a major housing shortage preventing people from buying or renting in Sedona and making current renters feel very insecure due to the possibility that the property could be sold or rents could be raised to an unbearable rate.

- Why are we approving more construction to bring in more bodies that we are unable to service. This is no longer a community; it is simply a cell phone app
- Wish we started the transportation sooner....if it wasn't for the crash of 2008 we wouldn't be so far behind.....now it's out of control
- With the growth that is occurring now the city needs to ensure that both water and sanitation resources are maintained via a comprehensive Capital Improvement plan that addresses environmental stewardship through sustainability policies. The city is not very well engaged with the local water companies and needs to understand these systems so they can make informed decisions about development. Water and sanitation are two fundamental resources that underpin this economy and the overall quality of life. Lose either one and you have a serious problem that is not easily remedied and will impact every other aspect of this community. Northern AZ does not have a water management organization or policy which is potentially a serious problem for future growth.
- Within ten years E bikes and pedal assist bikes will be as common as automobiles. Plan for it!
- YES Tourism dominated economy Lack of affordable housing and family friendly community opportunities Traffic/environmental consciousness - not just slogans
- Yes as mentioned plan for those of us who live here permanently and not just tourist. Lack of traffic lights at my neighborhood causes accidents and/or near misses. Back up of traffic is unacceptable from tourist and yet we put in more roundabouts to stop the flow, ridiculous.
- Yes, all of the above and there needs to be a plan for affordable housing for people who work in Sedona so they can also live near where they work and be invested in this community. It is sad to see Sedona go the way of places like Vail, Jackson Hole, etc. where the people who work there cannot live there.
- Yes, bringing medical profession into Sedona.
- Yes, the top three above
- You should note from my answers above that I strongly believe we need a very different kind of community plan. Not one that talks about what we think we want to build, pave, convert in use or other sorts of infrastructure items, but one that is focused on how we MANAGE our city and support our residents. No more lofty goal statements and "visions" videos but instead, we need serious evaluations of what we are actually getting from what we are doing and appropriate changes made in direction based on what those evaluations show.
- Zoning code change, permit more housing on existing lots.
