# Action Minutes City of Sedona

# Historic Preservation Commission Meeting Vultee Conference Room, 102 Roadrunner Drive, Sedona, Arizona Monday, April 11, 2022 – 4:00 p.m.

#### 1. CALL TO ORDER, PLEDGE OF ALLEGIANCE, & ROLL CALL

Chair Unger called the meeting to order at 4:00 p.m., led the Pledge of Allegiance and requested roll call.

#### Roll Call:

**Commission Members present:** Chair Brynn Burkee Unger, Vice Chair Kurt Gehlbach and Commissioners Jack Fiene and Bob Huggins. There are three vacancies.

Staff Members present: Cynthia Lovely, Jess McNeely and Donna Puckett

#### 2. ANNOUNCEMENTS & SUMMARY OF CURRENT EVENTS BY COMMISSIONERS & STAFF

Commissioner Fiene announced that on March 3<sup>rd</sup>, he made a presentation to a breakfast group called the Mavericks, and he talked about what we do and what training is needed, and he got some interest, so we may have another member in a month or two. Additionally, he reported that SB1270 has gone to the floor of the full House and for the Heritage Fund for FY 22-23, \$1 million is going into the fund, and for FY23-24, we have \$2 million going into the fund; hopefully it will start to rachet it up to the \$10 million that we were promised. Nationally, we did \$151.8 million and of that almost \$58 million went to State Historic Preservation Offices (SHPOs), and SHPO is putting out notices about the Tiki Oasis in old Scottsdale where they have the Polynesian Plaza. Tiki Oasis was the Valley Ho, and they are putting on this deal between April 28<sup>th</sup> and May 1<sup>st</sup>, so if you are interested in the historic preservation aspects of the mid-century hotel and other spots that still have the tiki theme, that is when it is going to occur.

Vice Chair Gehlbach announced that he went to Sedona Engraving and Copy, and they will give him some idea of the cost estimate regarding the Uptown plaques. They looked at a few already and were surprised we didn't do the all-weather type. They wanted to have all of them measured, so he will measure them and get the cost estimates. Cynthia Lovely suggested that next time, we can put it on the agenda, because we need details of what they are and where they are. Vice Chair Gehlbach noted that there are some cool ones in storage too.

Commissioner Huggins announced that he has put together a list of every historic sign in Sedona, so we can go through and tell their condition, etc.

Cynthia Lovely reported that as a Ranger Station Barn update, the renovation is coming along and should be done relatively soon, and the city has accelerated the project, so we will see that moving along quicker. They are already talking about the interior renovations.

Commissioner Huggins announced that Parks & Rec has moved to Brewer Road across from the Ranger Station Park.

Chair Unger indicated that she would entertain a motion to approve the minutes of February 14th.

MOTION: Vice Chair Gehlbach moved to approve the minutes. Commissioner Huggins seconded the motion.

VOTE: Motion carried four (4) for (Fiene, Gehlbach, Huggins and Unger) and zero (0) opposed. There are three vacancies.
