SUMMARY STATEMENT

<u>Background:</u> On August 2, 2022, the City of Sedona held a Primary Election. A.R.S. § 16-643 requires that all election returns be made public by determining the vote for each person voted for and the vote for and against each referred measure appearing upon the ballot at the election. The Primary Election was for the Mayoral seat for a two-year term and three City Council seats for four-year terms. Proposition 458, a Resolution proposing an extension of the Alternative Expenditure Limitation (Home Rule Option) for the City of Sedona, was also considered at this election.

In order for the election results to become official, they need to be canvassed by City Council and read into the City's record. The Results have been received from Yavapai and Coconino counties and are shown in Exhibits A and B to the Resolution.

A RESOLUTION OF THE MAYOR AND COUNCIL OF THE CITY OF SEDONA, ARIZONA DECLARING AND ADOPTING THE RESULTS OF THE PRIMARY ELECTION HELD ON AUGUST 2, 2022.

WHEREAS, the City of Sedona, Arizona held a Primary Election on the 2nd day of August, 2022 for the nomination/election of a Mayor for a two-year term and three (3) Councilors for four-year terms; and

WHEREAS, the election returns have been presented to and have been canvassed by the City Council as shown in the attached Exhibits A & B.

NOW, THEREFORE, BE IT RESOLVED by the Mayor and Council of the City of Sedona, Arizona, as follows:

Section 1. That the total number of ballots cast at said Primary Election, as shown by the Election Summary Reports, was 4,369.

Section 2. That, due to the passage of consolidated election legislation, Coconino and Yavapai Counties are not able to provide the number of ballots to be verified or the number of ballots rejected at the municipal level.
