The following spoke in favor of the proposed expansion and improvement of the Sedona Dog Park: Linda Brecha, Sedona, Sheila Harding, Sedona, Laurel Room, Sedona, Patricia Berry, Sedona, Peter Periharos, Sedona, Sandra Imnterso, Sedona, Salvadore Lopes, Sedona, Maria Denny, Sedona., Barbara Hess, Sedona, suggested small pebble rock over dirt be used at the park.

The following spoke voiced concerns regarding the proposed plan and improvement of the Sedona Dog Park: Dr. Jaqualine Vaughn, Sedona, stated she believes the plan is poorly designed and voiced concerns over the availability of the field and other field uses, Sue Shannon, Sedona, voiced concerns about parking and sustainability.

Brought back to Council at 7:19 p.m.

Motion: Councilor Thompson moved to approve an expansion of the Posse Grounds Dog Park, to include a new field area, comprised of a non-grass surface such as crushed granite in an amount not-to-exceed \$155,000. Seconded by Vice

Mayor Jablow. Vote: Motion carried unanimously with six (6) in favor (Moriarty, Jablow, Kinsella, Lamkin, Thompson, and Williamson) and zero (0) opposed.

Council asked staff to bring this issue back for consideration if the surface is not working at the park.

Seconded by Councilor Kinsella. Vote: Motion carried unanimously with six (6) in favor (Moriarty, Jablow, Kinsella, Lamkin, Thompson, and Williamson) and zero (0) opposed.

d. AB 2854 Discussion/possible action regarding a Resolution and Ordinance amending the Sedona City Code Title 8 (Health and Safety) by adopting amendments to Chapter 8.05 (Article II. Garbage and Solid Waste Containment) related to sections 8.05.070 and 8.05.080 trash regulations.

Motion: Councilor Thompson moved to approve Resolution No. 2022-28, establishing as a public record the proposed amendment to Sedona City Code Chapter 10.20 entitled "2022 Amendments to Sedona City Code Chapter 8.05 (Garbage and Solid Waste Containment)." Seconded by Councilor Lamkin. Vote: Motion carried unanimously with six (6) in favor (Moriarty, Jablow, Kinsella, Lamkin, Thompson, and Williamson) and zero (0) opposed.

Motion: Councilor Thompson moved to adopt Ordinance No. 2022-05 an ordinance of the Mayor and Council of the City of Sedona, Arizona adopting amendments to the Sedona City Code 8.05 (Garbage and Solid Waste Containment) related to trash

regulations; providing for a savings clause; and providing for repeal of any conflicting ordinances. Seconded by Councilor Lamkin. Vote: Motion carried unanimously with six (6) in favor (Moriarty, Jablow, Kinsella, Lamkin, Thompson, and Williamson) and zero (0) opposed.

e. AB 2857 Discussion/possible action regarding an Ordinance amending the Sedona City Code Title 1 (General Provisions) by adopting amendments to Chapter 1.15 (Penalties) adding a new Section 1.15.030 related to recording violations against real property.

Seconded by Councilor Kinsella. Vote: Motion carried unanimously with six (6) in favor (Moriarty, Jablow, Kinsella, Lamkin, Thompson, and Williamson) and zero (0) opposed

f. AB 2571 Discussion/possible direction regarding issues surrounding the COVID-19 pandemic and the City's response.

No discussion or direction. By majority consensus, Council agreed to remove this item from the agenda.

g. Reports/discussion regarding Council assignments.

Councilor Williamson attended the Affordable Housing meeting and said the Housing Manager, Shannon Boone, has received over 100 calls of interested applicants for the Rent Local Program from individuals and not corporate investors. She said future discussions will include what can be done to recognize housing heroes and Councilor Thompson suggested a landlord of the month award. Councilor Thompson attended the Sedona Recycles Board meeting and said their biggest challenge is the ability to retain and attract staff. Councilor Thompson also attended the Northern Arizona Council of Governments (NACOG) meeting. He said two at large members from the County serve on the Board, and Jennifer Perry will serve as new representative for Yavapai County. Councilor Lamkin attended the Coconino Plateau Water Shed Partnership meeting and said progress is being made regarding efforts to get legislature to work on items for the control of ground and surface water usage.
