Sedona Library Director Judy Poe, Village of Oak Creek, and Sedona Charter School Board Secretary John Griffin, Sedona, spoke in favor of the SUP.

By majority consensus, Council directed staff to install a three-rail split-rail fence and to extend the linear ft. of the fencing along the path where the City Engineer determines necessary.

Motion: Councilor Thompson moved to approve award of the construction contract with Standard Construction Company, Inc. for Phase One of Navoti Drive to Dry Creek Road Shared Use Path Project in an amount not-to-exceed \$498,694.78, subject to approval of the written contract by the City Attorney's Office, as amended. Seconded by Councilor Williamson. Vote: Motion carried with six (6) in favor (Moriarty, Jablow, Lamkin, Ploog, Thompson, and Williamson) and one (1) opposed (Kinsella).
