James Curry, Sedona, spoke regarding the County's contract with Altice and advised the company will be sold in upcoming future and urged Council to consider all other options available for an ISP and B funding, he recommended the City hire an expert to assist. Tom Binnings, Village of Oak Creek, voiced concerns with the development of the broadband and the negative reputation of Altice, he also recommended a consultant/expert be hired, Mary Chicoine, Lake Montezuma, spoke on behalf of VV Rio and encouraged a community centered approach and said the organization is willing to cooperate and work together with other agencies to attain better broadband service.

Seconded by Ploog. Vote: Motion carried unanimously with seven (7) in favor (Moriarty, Jablow, Kinsella, Lamkin, Ploog, Thompson, and Williamson) and zero (0) opposed.

c. AB 2882 Discussion/possible action regarding the approval of a Resolution authorizing the City of Sedona to enter into a purchase agreement to acquire the property at 2250 Shelby Dr. in an amount not-to-exceed \$1,500,000 and authorization of possible budget transfer of contingency and other funds of up to \$1,500,000 and authorization of possible cash transfer of General Fund monies of up to \$690,000.

Motion: Councilor Williamson moved to go into executive session at 7:49 p.m. Discussion and consultation to consider its position and instruct its attorney and designated representatives regarding negotiations for the purchase, sale or lease of real property located at 2250 Shelby Drive. This matter is brought in executive session pursuant to A.R.S. § 38-431.03(A)(7). Seconded by Councilor Kinsella.

Motion: Councilor Williamson moved to approve Resolution 2022-30 authorizing the City of Sedona to purchase the property located at 2250 Shelby Drive, City of Sedona, Arizona, for the sum of \$1,500,000 and authorizing the City Manager to execute the Purchase and Sale Agreement and associated documents required to complete the purchase, subject to approval of the written agreement by the City Attorney's Office, except to approve a six-month occupancy by current owner instead of twelve months. Seconded by Councilor Thompson. Vote: Motion carried with five (5) in favor (Moriarty, Kinsella, Lamkin, Thompson, and Williamson) two (2) opposed (Jablow and Ploog).

Motion: Councilor Williamson moved to approve a budget transfer of \$810,000 from the Affordable Housing Fund contingency account and \$690,000 from the Capital Improvements Fund Uptown parking garage project account. Seconded by Councilor Thompson. Vote: Motion carried with five (5) in favor (Moriarty, Kinsella, Lamkin, Thompson, and Williamson) two (2) opposed (Jablow and Ploog).

Motion: Councilor Williamson moved to approve a cash transfer of up to \$690,000 from the General Fund to the Affordable Housing Fund. Seconded by Councilor Thompson. Vote: Motion carried with five (5) in favor (Moriarty, Kinsella, Lamkin, Thompson, and Williamson) two (2) opposed (Jablow and Ploog).

Vice Mayor stated he voted against the purchase because he did not agree with the condition to allow the seller to occupy the property for six months.
