SR-89A & SOLDIERS PASS ROAD PZ19-00005 (ZC, DR) CITIZEN PARTICIPATION REPORT

INTRODUCTION

The purpose of this Citizen Participation Report is to provide a summary of the public outreach conducted in conjunction with The Village at Saddlerock Crossing (PZ19-00005) zone change and development review application. The Village at Saddlerock Crossing is a proposed lodging and multi-family residential development on approximately 6.36 acres in West Sedona. The property is located on the south side of the intersection of State Route 89A and Soldiers Pass Road in Sedona, Arizona (the "Property"). The Property is currently vacant land, and the applicant is proposing the development of a pedestrian-oriented mixed-use development featuring a 110-room boutique hotel and a 40-unit multi-family residential development with 28 permanent workforce housing units.

COMMUNITY MEETINGS

A total of four community meetings have been held over the life of this project, which was originally submitted in 2016. The applicant hosted two separate neighborhood meetings for this project under the previous application number (PZ16-00013) on January 17, 2017 and May 2, 2017. Approximately 50 people attended the January meeting and approximately 40 attended the May meeting. Attendees for both meetings consisted largely of neighbors to the south and west of the Property.

The application was resubmitted in 2019 under the current application number (PZ19-00005) and two additional community meetings have been hosted by the development team as outlined below:

NOTIFICATION

A total of three (3) notice letters have been mailed in conjunction with this application. Each letter has been mailed to all property owners within 300 feet of the subject site, as well as all property owners within the Saddlerock Homes subdivision to the south and west of the site.

- The first notification letter was mailed on **May 10, 2019** to provide residents notice of the application filing and provide an overview of the project. A copy of the mailing is attached at **Tab 1**. Phyiscal mailing labels for this notification were provided by the City of Sedona.
- The second notification was mailed on **July 2, 2021** to provide notice of a virtual community open house meeting to be held on July 19, 2021 at 5:30 pm. The letter encouraged residents to register for the virtual meeting and also provided a link to the project materials posted on the City of Sedona's website. A copy of the mailing notice and mailing labels are attached at **Tab 2**.
- The third notification was mailed on November 19, 2021 to provide notice of a community open house meeting
 to be held on-site at the project site on December 1, 2021 at 4:00 pm. The letter included a parking map to
 provide instructions for parking on-site if attendees were arriving by car. A copy of the notice letter and mailing
 labels are attached at Tab 3.

MEETING SUMMARIES

July 2021 Virtual Meeting

A total of 22 individuals registered for the July 2021 virtual neighborhood meeting, a copy of which is attached at **Tab 4**. The meeting opened with the developer's representatives providing an overview of the site plan and the changes that have occurred since the last time a neighborhood meeting was held. Attendees asked a variety of questions throughout the meeting related to lighting, building heights, construction timeline, elimination of the retail component of the project, resident access to on-site restaurant/bar/pool, and designated hotel contact in the event of issues/complaints once the hotel is operational. The development team responded to and answered all questions posed by the attendees before closing the meeting. A video recording of the meeting is available upon request.

December 2021 On-Site Meeting

A total of six (6) individuals signed in for the November 2021 on-site community meeting, a copy of which is attached at **Tab 5**. Prior to the start of this meeting, the project architect and engineer erected "story poles" around the site to illustrate building heights around the property. The development team and the attendees walked the site to discuss different elements of the project and view the story poles. Questions from attendees included traffic generation (comparison between existing commercial/MF zoning and proposed zoning), resident access to on-site restaurant/bar/pool, parking, vehicular circulation (particularly focused on access to the traffic signal at Soldiers Pass Road and SR-89A). The development team stayed on-site until all questions had been answered and all attendees had departed the premises.

ONGOING OUTREACH

The development team is currently conducting additional outreach to surrounding property owners and businesses to discuss the status of the project and changes that have been made since the previous meetings, gather additional input/feedback/support, and provide information regarding upcoming public hearings. This Citizen Participation Report will be updated accordingly as new information and input becomes available.






