I have read through the material from the developer for the Oxford Hotel. While the project includes some workforce housing note that 24 of these are 400 sq ft efficiency apartments. They mention 20-30 employees, but given 110 rooms (min 55 staff) and a 3000 sq ft restaurant and 1800 sq ft rooftop bar restaurant, I think that they are probably in the 80-100 staff range, so still a problem of workforce and this will further deplete the available workforce in Sedona.

The biggest issue is whether Sedona should accommodate the additional 110 rooms, which is a 7% increase in the number of rooms in town. The hotel rooms themselves are fairly typical 350 sq ft each. The fact that the hotel also features a large meeting with a ballroom and meeting rooms means they want to draw businesses, probably to compete during the off season when tourists are less abundant.

I am in favor of the changes by Council to no longer allow lodging in this CFA. I am opposed to the project as it expands the lodging in a community that is already oversupplied with lodging. Please reject this change in zoning requested by the developer.

Inspired by your group's recent presentation at the Citizens Academy, we'd like to make a few comments about the Village at Saddlerock Crossing project. We live in Saddlerock and travel in and out on Saddlerock Circle multiple times every day.

A large portion of the project parking lot (including the area where large buses will be parking) is highly visible to anyone walking or driving on Saddlerock Circle. This eyesore needs to be shielded from view with a landscaped berm, wall, fence, and/or vegetation *high enough and thick enough* to block views of these cars and buses.

Forty (40) multi-family units could easily add 80-100 cars to parking and local street congestion. What limits will be placed on the number of cars and people allowed per unit? Will pets be allowed? I would strongly suggest reducing the total number of units.

How many of the forty (40) multi-family units will be at market price rents and how many will be at reduced rents? How far below market? How many will be exclusively set aside for employees of the hotel?

Also, who is ultimately responsible for ensuring that the multi-family housing is maintained, kept neat and tidy, and tenanted with individuals who participate in this community by actually working here? What legal limits are there on such oversight? We don't want this to turn into a Section 8 housing, do we?

Thank you for your time today to discuss the development of the previous Biddle Nursery site. I am a retired architect who practiced in Des Moines, Iowa and now living in Sedona. In my career I was involved in several similar projects and have a few comments.

- 1. I have heard at many meetings the city needs multi housing. This is an opportunity for both the city and developer to work together and get some multi housing since this is probably the largest single tract of land along the 89 corridor.
- 2. The city wants interconnectivity to controlled intersections. In this case the extension of Soldier Pass is directly adjacent to residential rear yards. The curving nature of the road will allow headlights shining directly into the homes to the south. The homes to the south of the road will not be desirable if on the market.
- 3. The multi housing should be a buffer between the residential to the south and the commercial development to the north. However the property remaining may not be deep enough to meet the city requirement that the main building not be parallel to the highway. A well designed development could be parallel to the highway.
- 4. The CFA goal of making this area a walkable community where retired residents walk to the dentist and then the grocery store seems unrealistic based on five lanes of traffic and much tourist traffic. The entire strip is very pedestrian unfriendly as is any area severed by a main thoroughfare.

I arrived in Sedona in January and spent the initial months living in Airbnb accommodations, which quickly became unsustainable. Fortunately, in March, I managed to find a room to rent, but nothing affordable without roommates.

Sedona relies heavily on the hardworking individuals who form the foundation of its success, yet it's nearly impossible for us to find affordable housing that aligns with our salaries or wages. I was fortunate to stumble upon a midterm housing opportunity through a local resident who wasn't looking to profit excessively from renters for 4 months, at the end of which I still needed to find housing. These opportunities do exist, but they are rare and in high demand.

The critical need here is for solutions that for longer term housing that is not so prohibitively expensive. We need tourism accommodations such as Airbnb, and we do need to prioritize providing accessible and sustainable long-term housing options for those who wish to establish themselves here and build their livelihoods.

I have friends who are eager to make Sedona their home as well, but we are all facing significant challenges in our pursuit of affordable housing.
