## **RESOLUTION NO. 2023-29**

A RESOLUTION OF THE MAYOR AND COUNCIL OF THE CITY OF SEDONA, ARIZONA, ESTABLISHING AS A PUBLIC RECORD THOSE CERTAIN DOCUMENTS FILED WITH THE SEDONA CITY CLERK AND ENTITLED "FLOOD PLAIN MANAGEMENT CRITERIA [44 CFR 60.3]", "FLOOD INSURANCE RATE MAPS (FIRMS),"AND "FLOOD INSURANCE STUDY (FIS)", AS PREPARED BY THE FEDERAL EMERGENCY MANAGEMENT AGENCY (FEMA).

WHEREAS, the Department of Homeland Security's Federal Emergency Management Agency (FEMA) recently completed a re-evaluation of flood hazards in the City of Sedona, for both Coconino County and Yavapai County, Arizona, ("City"), and

WHEREAS, FEMA has prepared revised Flood Insurance Rate Maps (FIRMS) and Flood Insurance Study (FIS), and provided final copies to the City, and

WHEREAS, FEMA has now issued a Letter of Final Determination (LFD), dated August 8, 2023, requiring that the City to adopt by ordinance the current effective FIS report and FIRMS, together with the Flood Plain Management Criteria (44 CFR 60.3), specifically the floodplain management regulations of Section 60.3(d), and their subsequent revisions, within six (6) months as a condition of continued eligibility of the City in the National Flood Insurance Program (NFIP).

NOW THEREFORE BE IT RESOLVED BY THE MAYOR AND COUNCIL OF THE CITY OF SEDONA, ARIZONA, that those certain documents, and their subsequent revisions entitled, "FLOOD PLAIN MANAGEMENT CRITERIA [44 CFR 60.3]," and specifically the standards of Section 60.3(d) applicable to the City, and "FLOOD INSURANCE RATE MAPS (FIRMS)", and "FLOOD INSURANCE STUDY (FIS)", as prepared by FEMA, constitute public records to be adopted by reference pursuant to ARS 9-802.

These documents will be incorporated into Ordinances 2023-07 and 2023-08 by adopting the provisions as criteria for flood plain management in flood-prone areas identified by the FIRMS and FIS within the City limits.

At least three (3) copies of these public records shall be filed in the office of the City Clerk and kept available for public use and inspection.
