Classically trained as a violinist, Arvel's compositions + performances are a confluence of styles shown by his extraordinary love of diversity, which are revealed in his 25 CD releases. Five of his releases have earned him international music awards.

Arvel attended ASU on a music scholarship and later transferred to the Midwest where he continued his musical education and became a 4-time Indiana State Fiddle Champion.

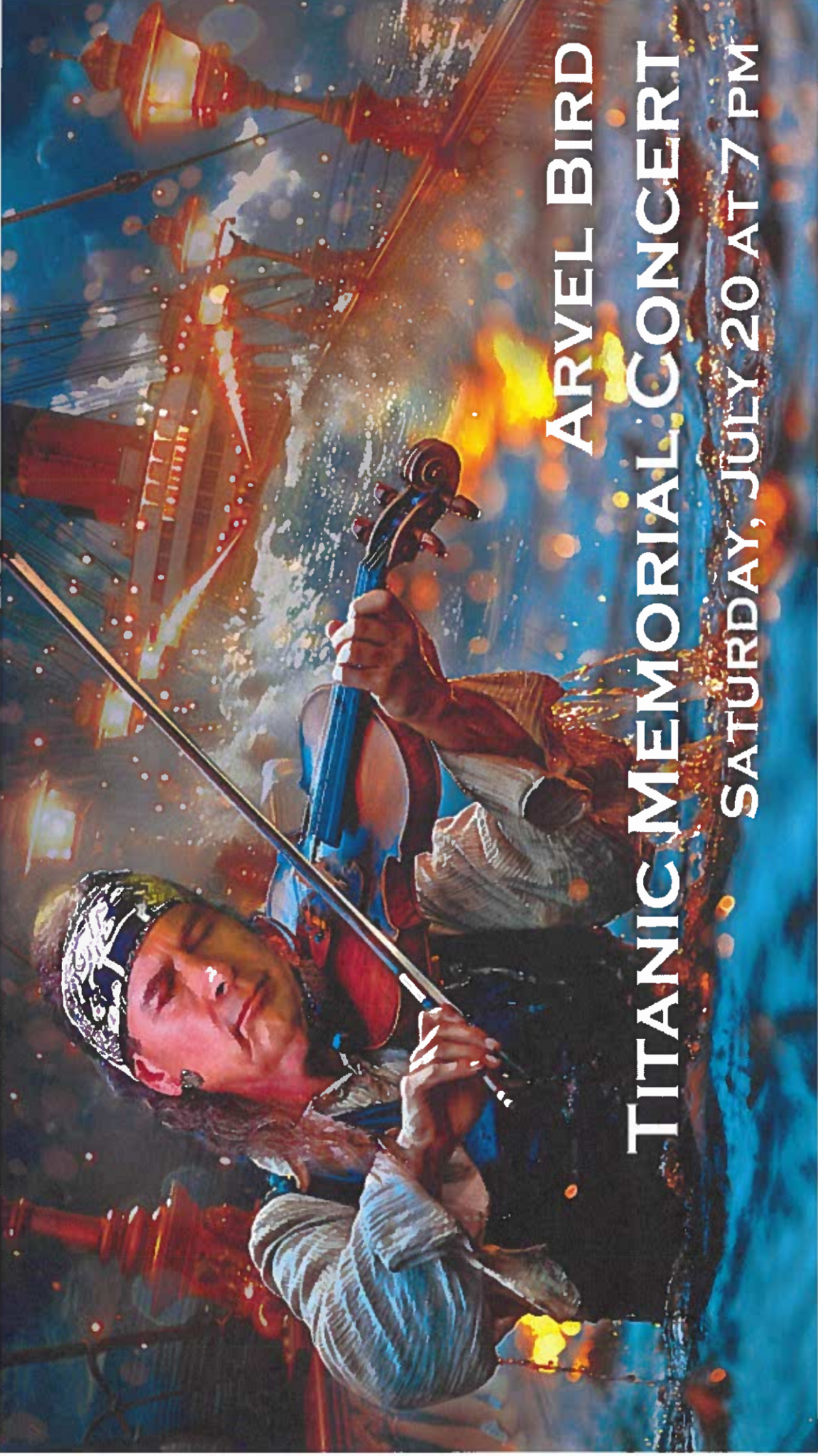
He has toured with Glen Campbell, Loretta Lynn, Tom T. Hall, Ray Price, Louise Mandrell & Clay Walker, which led him to launch his own successful 19 year solo career. Arvel has toured worldwide from Toronto's Sky Dome, London's Royal Albert Hall and Paladium to Washington DC's & NYC's Smithsonian museum and Florida's Kennedy Space Center.

Arvel will be performing his "Titanic Memorial Concert" at Mary Fisher Saturday, July 20 at 7pm. This will be a soul-stirring evening of music, stories and stunning graphics that take you on a journey aboard the Titanic. It is about seeing the beauty in the tragedy and dealing with our grief about loss, realizing that grief and loss are written into the fabric of life.

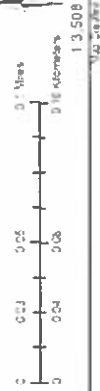

 - No units may be used for short term rentals
 - Term of restriction to be determined

Sedona will permit:

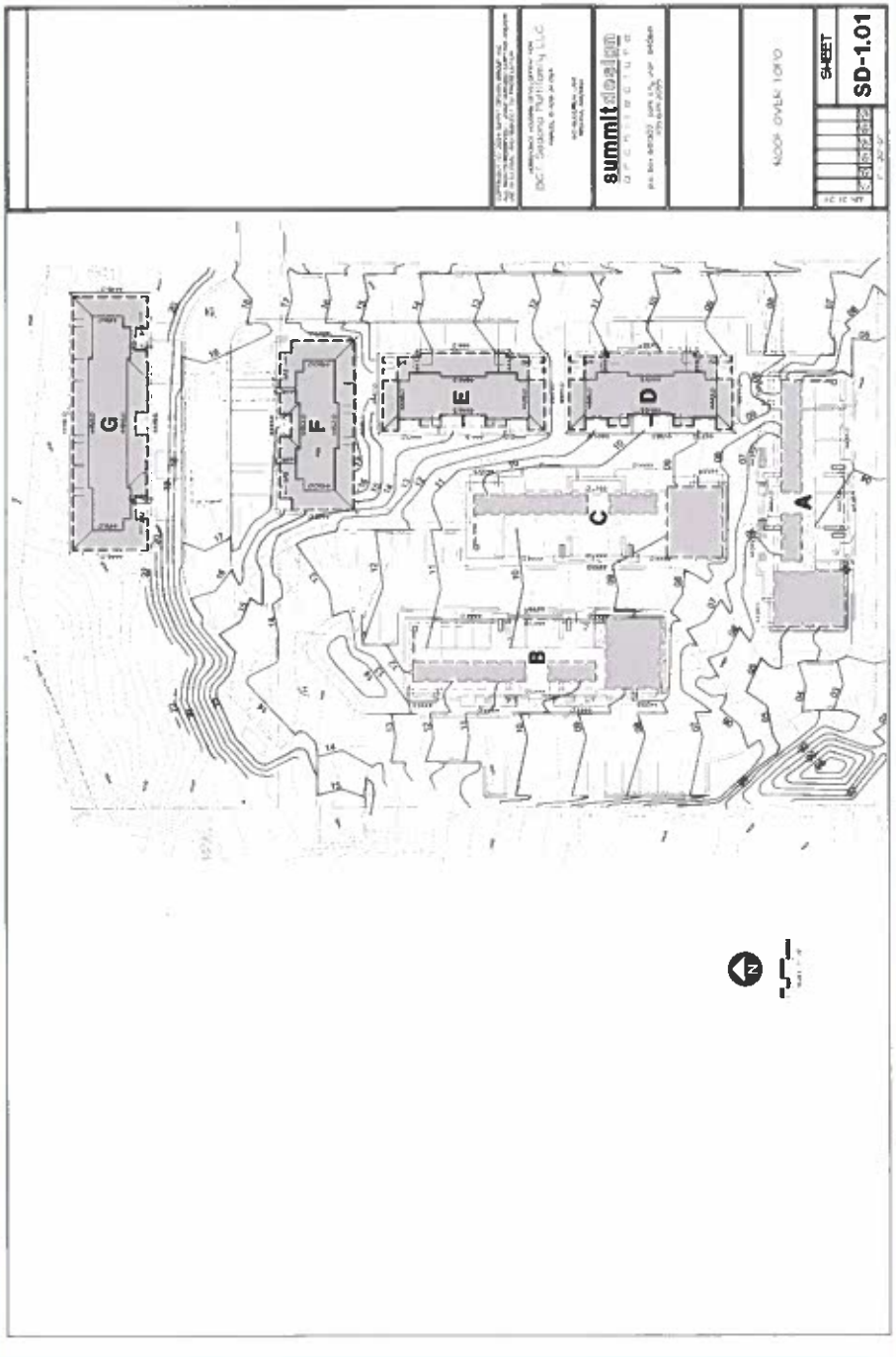
- **Increased Building Height up to:**
 - Building A: 40.5 feet above natural grade (“ANG”)
 - Building B: 41 feet ANG
 - Building C: 42.5 feet ANG
 - Building D: 36.5 feet ANG
 - Building E: 35.5 feet ANG
 - Building F: 37.5 feet ANG
 - Building G: 33 feet ANG
- **Setback Variance:**
 - Minimum front setback reduced by 15%, from 20 feet to 17 feet
